Article 4: Operating Budget

Shall the Mascoma Valley Regional School District raise and appropriate as an operating budget, not including appropriations by special warrant articles and other appropriations voted separately, the amounts set forth on the budget posted with the warrant or as amended by vote of the first deliberative session, for the purposes set forth therein, totaling Thirty Million, Four Hundred Nine Thousand, Four Hundred Fifty-Five (\$30,409,455) Dollars? Should this article be defeated, the default budget shall be Thirty Million, Two Hundred Fifty-Three Thousand, Eight Hundred Fifty-Six (\$30,253,856) Dollars, which is the same as last year, with certain adjustments required by previous action of the Mascoma Valley Regional School District or by law; or the governing body may hold one special meeting, in accordance with RSA 40:13, X and XVI, to take up the issue of a revised operating budget only.

Article 5: Negotiated Agreement Support Staff Personnel

Shall the Mascoma Valley Regional School District vote to approve the cost items included in the collective bargaining agreement reached between the Mascoma Valley Regional School Board and the Mascoma Valley Regional Support Staff Association which calls for the following increase in salaries and benefits at the current staffing level over those paid in the prior year:
