WELCOME ED MORRIS, ENFIELD TOWN MANAGER

We welcome Ed Morris as Enfield's new Town Manager!

As you may have seen in a December press release, the Town of Enfield announced the hiring of Ed Morris as its new Town Manager. His scheduled start date is January 10th. Mr. Morris will take over from Jack Wozmak, a Senior Municipal Management Consultant from Municipal Resources, Inc., who has served as the Interim Town Manager for about the last year. Mr. Wozmak and Mr. Morris will work to ensure a smooth transition.

Ed received his BS Degree in Business Administration, with a concentration in finance, from Colorado Technical University and his Master of Public Affairs from the University of Missouri's Truman School of Public Affairs. After serving as a firefighter in the City of Twin Falls Idaho for 17 years, Ed transitioned to a career in municipal management and served for 3 ½ years as the Town Manager in Weathersfield VT before being appointed as the City Manager in Claremont NH in 2019.

MASK REQUIREMENTS REINSTATED AT ENFIELD COMMUNITY BUILDING

On December 20th, the Board of Selectmen reinstated the requirement to wear face masks when inside the Enfield Community Building, **effective immediately**. This requirement applies to all functions, both public and private. Masks may only be removed when seated at a table and actively eating or drinking.

MUNICIPAL FACILITIES INFORMATIONAL SESSIONS

Planning for future needs of the Town began with a [Municipal Facilities Optimization Study](#) and was followed by deliberations and recommendations from the [Municipal Facilities Advisory Committee](#), a dedicate group of volunteers.

A brochure was recently mailed to all Postal Patrons in Enfield (03748) and Enfield Center (03749) inviting you, the citizenry of Enfield, to provide feedback to your elected officials. Two Public Informational Sessions will be held at the Enfield Community Building on January 24th and January 27th at 7:00 PM. Masks are required.



PUBLIC FEEDBACK IS NEEDED

The Enfield Board of Selectmen in cooperation with the Library Board of Trustees support the concepts of preserving and enhancing the buildings that contain these various town functions. Further, the Municipal Facilities Advisory Committee, made up of Enfield citizens, also supports projects of this type for the betterment of the community.

Ultimately, these projects will be included in a Warrant Article for Town Meeting. Feedback from the citizens is considered essential by both the Board and the Trustees.

INFORMATIONAL SESSIONS

To acquaint the public with these project initiatives, the Selectboard will be holding two public informational meetings in the Community Building so that the citizens of Enfield can learn more and ask questions about these projects.

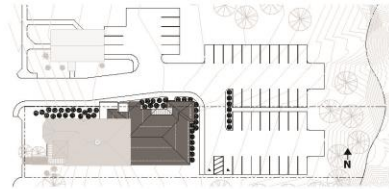

THE PROPOSED WHITNEY HALL RENOVATION/EXPANSION

The concept for the Whitney Hall, Library and Municipal Offices focused on developing a program for historic rehabilitation of Whitney Hall, as well as a rear addition.

The size of Whitney Hall would go from about 7,000 to 12,000 net square feet.

BACKGROUND

The Town of Enfield engaged Bread Loaf Corporation architects and cost estimators to undertake a conceptual study in 2020 which cost \$29,000 to look at opportunities for:

1. The renovation/expansion of historic Whitney Hall Library and Town Offices and;
2. The construction of a Public Safety Facility.

PURPOSE

The study was done in recognition of the fact that the current facilities are in poor condition and are inadequate in terms of space.

NEW PUBLIC SAFETY FACILITY

The concept for the new Public Safety Facility (Police, Fire, EMS) would move the facilities out of the current inadequate buildings and onto a new site, yet to be determined. The new building would house Police, Fire and EMS, expanding the space for the three facilities from about 7,300 to 14,900 net square feet.

2020 COST ESTIMATES FOR BOTH PROJECTS

Project costs for Whitney Hall, Library and Town Offices are estimated at **\$4.7 million**.

Project costs for the Public Safety Facility are estimated at **\$5.9 million** to which must be added any cost of land acquisition.

Thus, the total project cost would be about \$10.6 million for both projects.

Happy New Year!

The month of January is typically a quieter month for transactions. Fortunately, this gives us the time to do the final reconciliations and close the Tax books for 2021, and work on reports for the State and for the Town's Annual Report. The next billing will be for the 4th quarter water/sewer billings which usually are due sometime in early/mid-February. I will also be sending out notices of outstanding balances due for any 2021 Tax, Betterment, and Utility billings sometime in mid-January.

POLICE DEPARTMENT

From all the members of the Enfield Police Department welcome to 2022 and we hope everyone had a great new year. As we start the new year, and the weather continues to get colder, and the snowstorms keep coming, please remember Jessica's Law that requires the removal of snow from your vehicle prior to driving. This is important to help prevent crashes that could cause damage or, even worse, injury to others on the road. You must also properly defrost your vehicle prior to driving so that you can see and not be a danger on the roadway.

Recently we have had several instances of loose dogs running around within town. Please remember that it is your responsibility to ensure your dog does not leave your yard or is under your control at all times. When a dog is discovered, it is much more time consuming to find the owner when the dog is not registered. Please register dogs so that we can get them back to the loving home they belong to.

Over the past several weeks the department has received calls from concerned citizens regarding ice fishing and use of the frozen lake. CEMETERY DEPARTMENT

As noted in the Cemetery [Rules & Regulations](#) all items were cleared from the cemeteries. LAND USE AND COMMUNITY DEVELOPMENT DEPARTMENT NEWS

The Enfield Zoning Board of Adjustment (ZBA) met in December on the 14th. This was a hearing for Land Use Case #Z21-12-01 where BMB Real Estate requested a variance to Enfield's Zoning Ordinance (Article IV, Section 401.1) to allow for a self-storage business to be constructed and operated in the "R1" Residential Zoning District. The subject property is located at 223 US Route 4 (Tax Map 33, Lot 5) and is currently owned by Walter Brown III and Janine Brown (Brownies Auto Parts). This parcel is partially located within both the "CB" District and the "R1" District. After a healthy discussion and hearing input from neighbors, the ZBA voted to grant this variance. The Planning Board (PB) met on December 8th for a work session. Most of this meeting was related to the proposed 2022 Zoning Ordinance changes/amendments. A narrative summary of these amendments is now up on the Planning Board's section of the website. It is called "Zoning Amendments Articles Narrative 2022." The actual language of what is being proposed is also available on the website in a document titled "Draft Zoning Articles 2022 Warrant." At their January 12th 2022 PB meeting, there will be for a formal hearing on the Zoning Ordinance Amendments (see the official hearing warning/posting below) as required by State of NH law. NOTICE OF PUBLIC HEARING ON
PROPOSED ZONING ORDINANCE AMENDMENTS**

Notice is hereby given that the Enfield Planning Board will hold a public hearing at the Enfield Public Works Facility located at 74 Lockehaven Rd. and on the Zoom Web Meetings Platform on Wednesday, January 12, 2022 at 7:00 PM, to act on the following items: Amendments to the Enfield Zoning Ordinance.

The proposed amendments include those relating to:

- Proposed changes and additions to the "land use definitions" section of the Zoning Ordinance (ZO) related to "road frontage" and "streets giving access to a lot." The goal is to incorporate the State of NH's definition of a "street" found in RSA 674:41.
- Proposed changes to the language in R1, R3, and the R5 residential zoning districts' description for their frontage requirements to reference the "streets giving access to a lot" instead of a "public right-of-way."
- Proposed changes to the lot coverage requirements in the Commercial/Industrial (C/I) zoning district.
- Deleting the "Village Plan Alternative" section (405.2) of the ZO.
- Changes to the sign ordinance (Section 408) to provide for regulation of color, animation, and changeable content. In addition, language is proposed that clarifies the requirements for permitting, maintenance, and removal of signs.
- The creation of a new zoning district to be called the "Village Residential District" (VR) that would be limited to two Town owned parcels on Shedd Street (formerly the Public Works Facility). This new district would allow for the possible development of multi-family housing.

The Master Planning Task Force held two meetings in December (on the 13th and the 27th). The Task Force is continuing to work with our contractor, Brandy Saxton, of PlaceSense of Hartland, VT. Brandy has developed an outline of the Master Plan and worked up a timeline for completion. The Task Force and Brandy started with the “Economic Development” chapter of the plan and moved next to the “Transportation” chapter. Results of the recent Community Survey have been reviewed and are being incorporated into the work on the Master Plan. All are encouraged to attend any of the twice a month (on the second and fourth Mondays) Master Planning Task Force meetings as they continue to be very productive and collaborative.

FYI, the ZBA, Planning Board, and Master Planning Task Force meetings (as well as other boards) can now be watched on the Town’s new YouTube channel. The address of this channel is: <https://www.youtube.com/channel/UCqUIDZ5agHCfXR3bJKOzgPw> These recordings are taken from the Zoom web meeting camera and so far seem to be a decent representation of the respective meetings. We’ll continue to fine tune the setup and make small improvements in the technology as needed.

BUILDING INSPECTOR/HEALTH OFFICER

Financial Assistance for Heating Oil Tank Replacements

NH Department of Environmental Services is looking to increase awareness of the Safetank program among residents of New Hampshire cities and towns who may need financial assistance. This nearly 20-year-old program provides reimbursement to eligible homeowners of up to \$2,250 for the replacement of an aboveground heating oil tank if they meet certain income criteria as established by U.S. Department of Housing and Urban Development (HUD). The program also has funding to assist qualifying homeowners with the removal of residential underground heating oil tanks.

The income criteria to qualify for state reimbursement for heating oil tank replacements varies from town to town and is based on 80% of the median income for the town and the number of persons living in the household. For Enfield the criteria are as follows:

1 person--	\$49,300
2 person--	\$56,350
3 person--	\$63,400
4 person--	\$70,400
5 person--	\$76,050
6 person--	\$81,700

The Safetank program requires either an oil company or a plumbing and heating contractor to verify the condition of the oil tank prior to approving state reimbursement, and reimbursement needs to be approved prior to tank replacement in order to qualify. Heating oil is considered a hazardous material. All residents with oil tanks should consider the significant lifestyle disruption, environmental hazard, fire risk, and high costs associated with cleanup of leaks. Residents should have their tank evaluated for the following conditions which indicate poor condition and may require tank replacement:

- Is the tank presently leaking?
- Are the tank legs corroding, unstable, tilting or on an uneven foundation?
- Is the tank resting on or in contact with the ground or a dirt floor?
- Are there visible signs of rust, wet spots, blisters, or dents on the tank surface?
- Are there any signs of leakage around the oil filter, fuel line, or valves?
- Is the underground copper fuel line in direct contact with concrete?
- If the tank is located outside, can it be damaged by ice or snow falling from the roof?
- Is the overfill vent whistle obstructed by ice, snow, or insect nests?
- Is there oil staining on the top of the tank?
- Is the tank sight gauge missing, stuck, or cracked?

NH Fire Code requires oil tanks that have been permanently removed from service to be emptied of all liquid and sludge, cleaned and rendered free of combustible vapors, removed from the property, and properly disposed of in accordance with state and federal rules. Additional code requirements for oil tank installations include a five foot separation from an oil burning appliance unless separated by a fire-rated wall. Tanks and their supports should rest on foundations made of solid concrete. The tank should not obstruct access to electrical panelboards or shutoff valves. Tanks designed for use underground cannot be placed

aboveground, and vice versa. Tanks installed in areas prone to flooding must be anchored, and their vents should extend above the maximum flood stage water level.

DEPARTMENT OF PUBLIC WORKS

Winter Ban

The Enfield Board of Selectmen wishes to remind citizens of Enfield that the Winter Parking Ban is in effect from November 1 through April 1.

No vehicle shall at any time be parked on any public or publicly maintained street, alley, roadway or way open to the public, in a manner that hinders in any fashion the maintenance of the way.

Driveway Snow Placement

A reminder that it is unlawful to plow snow across any and all Town or State roads or to deposit snow within the traveled portion of a Town road pursuant to RSA 236:20, Paragraph VII, and RSA 41:11.

2022 Transfer Station Stickers Available

The 2022 Transfer Station window stickers are available at the Town Office and the Transfer Station. An Enfield vehicle permit sticker must be affixed to the window of your car or truck on the side window behind the front passenger's seat, or with regular cab pick-ups in the lower corner of the rear window behind the passenger. Permit stickers are available, free of charge, at the Enfield Transfer Station & Recycling Center or Enfield Town Offices. Proof of residency or property ownership is required.

Enfield permit stickers also permit you to use the town beach parking lot on Mascoma Lake and access to the driveway sand located at the DPW.

DPW Staff will be enforcing the sticker requirement at the Transfer Station and the citizen sand pile beginning in early January. In the era of the pandemic please plan ahead and obtain your sticker before you need it.

Water/Sewer Bills

Fourth quarter water and sewer bills will be mailed out in early January.

Water/Sewer Rate Changes

Effective January 1, 2022 the water and sewer user charges will be increased. The water usage rate has been increased by 5%. On the sewer side the consumption charges have been increased by 8%.

“KNOW YOUR TOWN”

“Know your Town” is presented by the Enfield Heritage Commission. Each month we’ll bring you a bit of insight into the origins of street names or places you see every day.

The Roads of George Hill

The area known as George Hill, which is located between the Bog Road, George Pond and the hills east of Enfield Center village, was first settled in 1798 and George Hill Road is one of Enfield’s earliest thoroughfares. From Enfield Center the road travels a mile up the hill to the height-of-land, before going another two miles to Enfield’s current town line and from there to Springfield.

George Hill road originally ran in a nearly straight line through land to the west of its current location until it joined the Fourth New Hampshire Turnpike (Route 4A) near George Pond. The road’s route was changed from its original straight line to enter the Fourth New Hampshire Turnpike at a four-way intersection with Rollins Road (Boys Camp Road). Some years later, the road’s path was changed again to pass the front of the George Hill Cemetery; this is its current location. Until the 1950s the road was unpaved and its muddy conditions in early spring caused the residents some difficulty.

George Hill Road meets the Bog Road at McDaniel Marsh, forming the western boundary of the area. Bog Road follows the hillside and returns to the Fourth New Hampshire Turnpike at George Pond.

There are a few other roads in the George Hill area. The Choate Road (Palmer Road) branches off from George Hill Road and runs about a mile and half before coming to a dead end at the site of the original Choate farm. Another road, called the Bluejay Road leads off the Choate Road; it originally ran between George Hill Road to the Fourth New Hampshire Turnpike. There were no settlements on this road, which has since been discontinued.

Another discontinued road, the Old County Road at the Springfield town line, ran over the mountain to the Bog Road. It provided access to the Whittemore farm and the Grantham

Meeting House. Today's map of Enfield shows an annex at the very southern part of George Hill. This was originally part of Grantham. Because the original landowners found travel over the mountain to Grantham inconvenient, on January 13, 1837 this section was annexed to Enfield, apparently to the great satisfaction of those who lived on that part of George Hill.

The cemetery at the foot of George Hill Road was laid out prior to 1800 and enlarged by residents who received a burial lot in exchange for their efforts. Many original settlers are buried here and a walk through the cemetery reveals their names and history. There is also the small private Adams Cemetery, which is surrounded by an iron grill-work fence and a stone inscribed "H. Adams 1861". George Hill road was also home to one of Enfield's first schoolhouses, established in about 1780.

George Hill Road is the site of significant farms, several dating to around 1800. Prominent among these were the farms of the Little and Edwards families, who owned large tracts of the land annexed from Grantham. Some of these original tracts still belong to descendants of the original two families; this represents seven generations of continuous ownership. Remnants of what was a significant orchard located at the beginning of the hill can be seen along the road edges. Before the forests in the area grew up, a traveler descending George Hill could see George Pond, Mascoma Lake and Crystal Lake in the distance.

The George Hill area remained basically unchanged for several decades. Although more recently it has experienced growth in private homes and population, it still holds a its place in Enfield's early history.

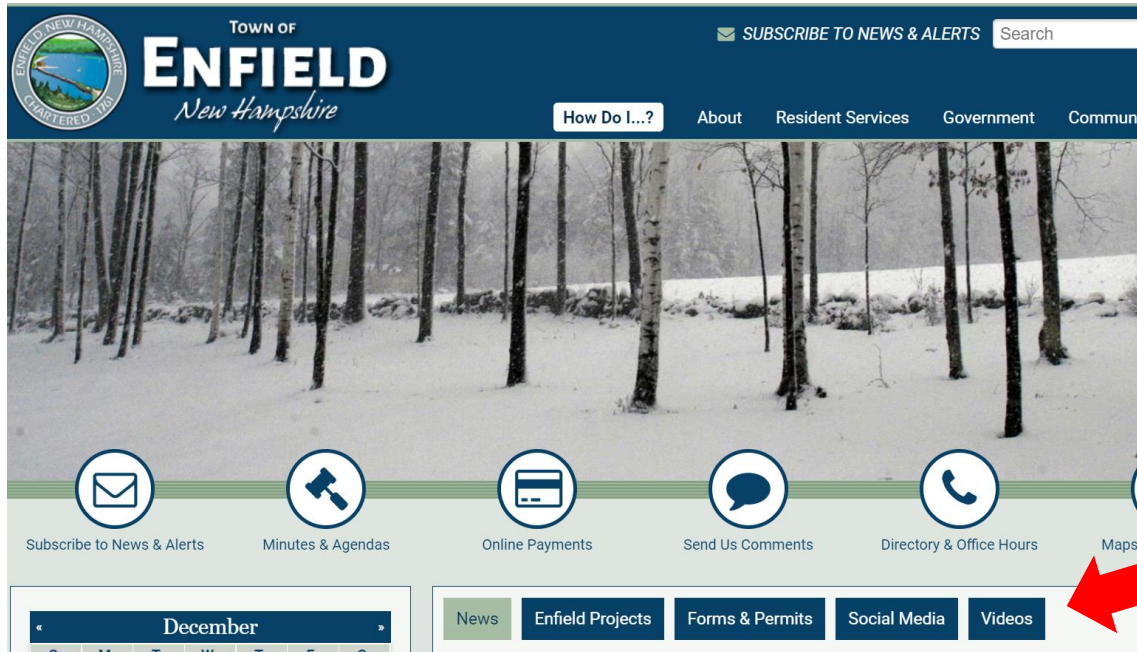
All public meetings are now being held **in person**. Masks are currently required in all public municipal spaces so must be worn if attending an indoor public meeting.

The LMAC has 19 members representing lake-front municipalities, planning boards, conservation commissions, realtors, NH Lakes, the State Conservation Committee, the scientific community, tourism, business and industry, fishing, marine dealers, the Fish and Game Commission, conservation, and state agencies. The LMAC provides a forum for exchanging technical assistance and ideas among state and federal agencies, municipalities, private businesses, conservation interests, and the public regarding lake management issues. The LMAC provides input on state legislation related to lakes and ponds, making recommendations both to the NHDES Commissioner and to state legislators in support of healthy lakes and public access.

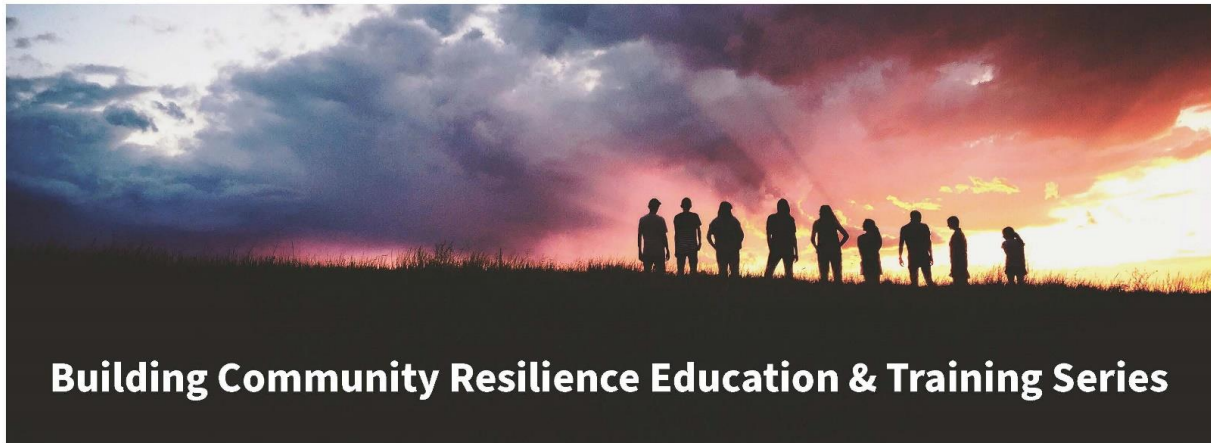

Capital Improvement Program Committee – The CIP Committee, as it's known, has two vacancies.
