At the second session of Town Meeting the voters will be presented, discuss and act upon the remaining articles on the warrant.

ENFIELD FIRE DEPARTMENT - ONGOING DEVELOPMENTS

Actions over the last couple of weeks have understandably led to much public confusion and concern as it relates to the current status of the Enfield Fire Department. As I am sure everyone can appreciate, this is a somewhat complicated situation with a lot of moving parts. This is not the right forum to attempt to explain what has transpired within the Fire Department in recent days. The reality is that many of the recent events are not fully understood by me or the members of the Board of Selectmen due to the fact that the Enfield Fire Department acts somewhat autonomously within our municipal government because it is governed by a board of three elected firewards.

A considerable amount of thoughtful deliberation has taken place over a series of months that ultimately led to the proposed changes in Fire Department governance that the Board of Selectmen has included on the warrant for our upcoming Town Meeting. This evaluation has benefitted from the professional assistance from multiple independent organizations, including the Center for Strategic Governance and Municipal Resources, Inc. (MRI). It should be noted that MRI has decades of professional experience doing operational assessments in the field of public safety. We are actively considering additional ways to effectively share pertinent information and gather public input on this important topic between now and Town Meeting. This will likely include a public forum prior to Town Meeting, and additional details will be shared soon. We hope you will come to Town Meeting to consider the rationales for what is proposed and participate in the decisionmaking process. When it comes to information about this article and other articles being presented to the voters at Town Meeting, I would strongly encourage residents to review the warrant article narratives that we have posted to the Town's official website:

Having said all of this, I want to publicly state that our Fire Department is comprised of many dedicated volunteers. Several of these individuals in particular have demonstrated incredible commitment by responding to consecutive calls at late hours of the night. Although there may be some tensions and disagreements that are regrettably playing out in public view, I want everyone to know that our community continues to be safe. In addition to those members of our own volunteer Fire Department who stand ready to provide help whenever and wherever it is needed, Enfield receives fire/EMS support from surrounding communities as part of our mutual aid agreements. Neighbors continue to help neighbors. As Assistant Chief John Pellerin said in a recent message to all members of the Fire Department, "We took an oath to protect life, property, and the environment for the citizens of Enfield, and the surrounding towns. We have a duty to act." I hope such conviction - which I know is shared among many members of our Fire Department – will help reassure all residents during these difficult times that help will continue to arrive if you need it.

MASCOMA LAKESIDE PARK – CLOSING SCHEDULED FOR MARCH 4 AND PROGRESS ON PLANNED IMPROVEMENTS

We are excited to report that the Town is scheduled to close on the sale of the Mascoma Lakeside Park property from NH DOT on March 4 (Monday). This milestone has been made possible by the commitment and dedication of many volunteers comprising the Mascoma Lakeside Park Committee, and of course the residents, businesses, charitable foundations, and other

interested parties that have made monetary donations to this project. It is an enormous achievement to be able to acquire this property exclusively with privately raised funds and manage it as a public park in perpetuity.



Once the sale is finalized, our focus will be squarely on amenities for the park. This past fall we have actively solicited public input through a series of meetings with local organizations, town committees, and a well-attended public forum held at the Community Building. The top priority for all stakeholders is that the natural

beauty of the site be preserved and not over-developed. Some improvements are also needed and desired. They include removing and replacing brush and trash trees with native shrubs and trees; creating trails and educational signage to enhance recreational use of the property; constructing rainwater gardens and a new retaining wall to protect the water quality of the lake; installing a children's wading/swimming area; improved parking; installing grill boxes, and; building a shelter or pavilion (which may include a fire pit) that can serve as a gathering place and an educational facility.

As has been previously reported, the Town of Enfield was recently awarded a Northern Borders Regional Commission grant in the amount of roughly \$135,000 to help fund improvements to the park property. This federal grant is a "match" grant, and the total project budget is approximately \$270,000. We have until July 2019 to raise \$135,000 in matching funds, at which point we will receive whatever portion of the \$135,000 we have matched. Our fundraising tally is approximately \$228,000. This leaves us with approximately \$100,000 of our \$135,000 goal to fund planned improvements once the \$128,600 sale price is deducted. So, we are well on our way to achieving our \$135,000 goal, but we still have to raise approximately \$35,000 over the next few months to secure 100% of the federal matching grant. Your generous support is needed!

MUNICIPAL FACILITIES OPTIMIZATION STUDY

As has been previously reported, beginning in the fall of 2018 the Town of Enfield began working with an experienced architect (Barrett Architecture) and engineering firm (Schaal Engineering) to perform a comprehensive assessment of our existing municipal buildings and conduct a space needs analysis to help inform future decisions related to long-term planning, operations and capital investments. The goal of this effort is to develop a

comprehensive facilities plan for both short- and long-term planning. The project involves an evaluation of our existing municipal buildings (including the likely costs of maintaining and renovating them in the longer-term) and conducting a thorough analysis of alternative approaches that might prove to be more cost-effective as well as enable Town departments to provide an enhanced level of service to residents.



Barrett Architecture has evaluated numerous sites for the possible construction of a public safety complex (which would house Police, Fire, and Ambulance departments) and has also examined several alternatives for improving Enfield's Town Offices and Public Library. We anticipate that this preliminary analysis and design phase will be completed within the next few weeks. At that time, it is our intention to convene a public forum for any and all interested residents to attend and provide feedback on the full range of options that have been examined thus far. The Board of Selectmen and Town administration very much value resident input and are striving to develop a plan for improving municipal facilities that has broad-based support from members of the community.

It goes without saying that any significant capital investments proposed will be thoroughly deliberated and dissected by municipal officials and pertinent boards/committees moving forward, and public feedback will help ensure that we consider all the appropriate angles. We have been very candid with Barrett Architecture and Schaal Engineering about the fiscal constraints we face, and have impressed upon them the importance of developing cost-effective strategies that will meet our needs in both the mid- and long-term while still allowing the Town to live within its financial means and remain affordable to working individuals and families.

DEPARTMENT OF PUBLIC WORKS

Punch Cards for Transfer Station Fees

The Town is working on establishment of a punch card system for Transfer Station fees. The new system should reduce wait times for residents. Punch cards will be available at the Public Works building payable by check only. Punch cards will also be available at the Enfield Town Offices, payable by cash or check. 2019 Transfer Station Stickers Available

The 2019 Transfer Station window stickers are available, free of charge, at the Town Office and the Transfer Station. Proof of residency or property ownership is required. An Enfield vehicle permit sticker must be affixed to the side window of your vehicle behind the front passenger's seat, or with regular cab pick-ups in the lower corner of the rear window behind the passenger.

Enfield permit stickers also permit you to use the Town's upper beach parking lot on Mascoma Lake.

Road Postings

The Town of Enfield will be posting roads in early March. The State of New Hampshire will be posting Shaker Hill Road and Main Street. Limited permission for access will be available on a case by case basis with factors such as weather, truck size, time of day, etc., being taken into consideration. The Enfield Water/Sewer Department will be reading meters beginning March 18 for first quarter 2019 billing. Please have touch pad locations shoveled out and sanded for access.

Driveway Snow Placement

A reminder that it is unlawful to plow snow across any and all Town roads or to deposit snow within the traveled portion of a Town road pursuant to RSA 236:20, Paragraph VII, and RSA 41:11.



Driveway Sand

Driveway sand is available at the DPW during their business hours (Monday-Friday from 7:00 AM to 4:00 PM) and is located at the top of the driveway in the bin on the right. It is open to Enfield residents with a current Transfer Station Sticker. It is not intended for commercial applicators or to be taken in commercial volumes. Salt, ledge sand and materials in the shed, and sand from the large pile to the left of Public Works building, are NOT available.

Winter Parking Ban

The Enfield Board of Selectmen wishes to remind citizens of Enfield that the Winter Parking Ban is in effect from November 1 through April 1. No vehicle shall at any time be parked on any public or publicly maintained street, alley, roadway or way open to the public, in a manner that hinders in any fashion the maintenance of the way.

ANYONE with 25 gallons or more or any business must pre-register.

Alkaline batteries: Most non-rechargeable batteries (AA, AAA, C, D, and 9-volt) are trash in NH. If in doubt, just bring to collection. Tape 9-volt terminals before disposal.

Ammunition and explosives: State Police at 271-3636.

Asbestos: Get a licensed asbestos specialist. Asbestos is

hazardous to your health—don't even think about removing it yourself! Automotive batteries: Take to parts store for cash back or your transfer station Empty aerosol cans: Can be recycled with scrap metal. Talk to your town. Fluorescent lights: May be taken at your town facility. Check with your town. Food Co-ops and Home Depot take may take CFLs (spiral bulbs), not tubes. Latex paint: Use kitty litter, sawdust, or shredded paper to dry out latex paint, then throw in your trash. Empty, dry metal cans may be recycled as scrap metal at your recycling facility. If it says "clean up with soap and water," it's latex. Medicine: See www.twinstatesafemeds.com for police stations taking meds. Medical sharps: Place in a rigid container (e.g. detergent bottle), seal cap with duct tape, and label container with marker, "Sharps, not for recycling." Dispose of with regular trash by handing to a waste collector. See www.nh.gov/medsafety. Can drop off at Lebanon Police Station. Propane or helium tanks and fire extinguishers: Propane/helium tanks can be exchanged/refilled at a distributor; or contact town transfer station about empty tanks. Empty fire extinguishers can be recycled (NRRA takes from towns). Used motor oil: Take to town transfer station or a service station for recycling.

BUILDING AND FIRE INSPECTOR

Smoke and carbon monoxide detectors do provide an early warning, helping to prevent a potential disaster. Batteries should never be removed from the unit for any reason and, if the alarm sounds, we must take advantage of the time it is giving us to vacate the building. They are our early warning system, do not second guess them. **Call 911 immediately.**

Detectors generally have a 10-year life expectancy before they need to be replaced. Batteries should be changed twice a year, change the clock, change the battery.

All fire departments within the Mascoma School District carry Smoke and C/O Detectors that can be left with homeowners in the event that a faulty unit is found during a call, no one should be left unprotected. These units have been generously provided free of charge to the departments by the Assembly of God Church in Canaan. Other donors are always needed, as to date we have given out over 120 units. PLANNING & ZONING OFFICES

The Enfield Planning Board met on January 9 to review potential zoning ordinance changes and prepare for a public hearing on the topic. On January 21, the Planning Board held a public hearing on the zoning ordinance changes and voted them to town meeting. The February 13 meeting was canceled.

The Planning Board's February 27 meeting included three conceptual meetings to talk informally to Chris McGrody about a potential subdivision, to Jeff Reed about a potential subdivision, and to Tom Hersey to discuss his heavy equipment storage. They do not currently have applications scheduled for review in March (but that could change).

The Zoning Board of Adjustment (ZBA) met on January 8 to review a variance request for illuminated signs for the new Jake's. They did not have any hearings in February. On March 12, they will review a variance request for a duplex in Enfield Center.



PUBLIC WORKS COLLEGE INTERNSHIP PROGRAM

The Town of Enfield, NH, Department of Public Works is offering an internship program to an advanced undergraduate or graduate student that involves assisting the Public Works Director with several important

infrastructure planning, asset management, and geospatial data collection projects. The primary project will be developing a town-wide road plan that includes collecting data on surface condition, culverts and drainage structures, vegetative cover, and signage. This inventory will be used in a work management system and for short- and long-term budgeting and capital planning. Other projects include assisting with asset management projects for both the water and sewer systems that are currently



underway. The intern will also gain valuable knowledge by actively collaborating with our Public Works staff, other municipal departments, and consulting engineers in the course of completing the project. The intern will be exposed to a number of different data collection techniques and analytical tools in the course of the project. As time allows, the intern may also provide direct support to the Planning and Zoning Offices in fulfilling additional community objectives (i.e., master planning). Candidates must be self-motivated and able to work independently and as part of a team. This is a 12-week paid summer internship (rate of pay will be based on the experience of the selected applicant) and the Town is also willing to work with students who are able to achieve college credit for internship work that continues into the fall semester.

2019 WATER & SEWER RATES AND ONGOING STUDIES

In December 2018, the Enfield Water & Sewer Commissioners (Board of Selectmen) voted to adjust water and sewer rates in accordance with the formal recommendations offered by the Town Manager and Public Works Director. The new rates became effective January 1, 2019 and will appear in the first quarter bills arriving in your mailbox the first week in April 2019. The adopted increases include for following:

Water Rates

- Fixed charge increased \$2 per quarter for usage <u>under</u> 10,000 gallon per quarter
- Fixed charge increased \$7 per quarter for usage 10,000 gallons and over per quarter
- Consumption charges have been increased 5% for both usage levels

Sewer Rates

- No change to fixed charges
- Consumption charges have been increased 8% on both usage levels 2.5% increase on the deficit reduction fee (which is consumption based)

The changes in the rates were approved to ensure that the amount of revenue collected is adequate to cover the annual operating and capital costs associated with these systems. As is widely known, over the course of several years the Town of Enfield's Sewer Fund began operating in a deficit. This was effectively the result of user fees failing to keep pace with rising operating costs. Unfortunately, significant changes in the rate structure had to be made beginning in 2018 to start remedying this problem and thus improve financial strength/integrity of the Sewer Fund and municipal financial position overall. The adopted changes in the sewer rates in 2019 were

necessary to ensure that we remain on a trajectory to eliminate the deficit within the next several years.

Although it is true that the Water Fund does enjoy a healthy surplus, a 5% increase in the consumption rates (and roughly equivalent increases in fixed costs) was needed in order to ensure that the revenue collected in 2019 kept pace with projected operating costs in the same budget year. Although inflation across all segments of the economy (as measured by instruments like the Consumer Price Index) might be +/- 2% in a given year, the reality is that rates of inflation in sectors of the economy related to construction and infrastructure have been appreciably higher (5-7% in many cases). As a result, maintaining the municipal water system at its current level will result in the Town incurring additional expense. Furthermore, given what transpired over time with the Sewer Fund, we must be cognizant of how a surplus in a given fund can erode to a deficit relatively quickly if user fees fail to keep pace with the true costs of operating and maintaining the system.

It is also important to note that multiple projects are presently underway that are helping us better understand the current state of our municipal water and sewer infrastructure, and this information will be of critical importance when it comes to establishing a baseline, undertaking longer-term capital planning, and setting usage rates. One of the projects will include a thorough evaluation of alternative methods of treating Enfield's wastewater and help us evaluate the feasibility (including the financial feasibility) of constructing our own wastewater treatment plant in the interest of reducing operating costs in the long-term. These projects are being completed with funding support from the NH Department of Environmental Services.

The Water & Sewer Commissioners, Town Manager, and Department of Public Works are committed to keeping the Water and Sewer Departments financially sustainable while delivering quality water and sewer services into the future.

MUNICIPAL WATER SYSTEM - LEVEL OF SERVICE PUBLIC FORUM

Enfield officials and representatives from Horizons Engineering held a public forum/workshop on February 21 in the Enfield Community Building to provide the public information about the current condition of the municipal water system (including likely upcoming capital improvement needs) and obtain resident feedback that will help inform the goals and objectives we set regarding desired levels of service moving forward. We want to thank those residents (and users of the water system in particular) who attended the session to convey your valued input.

PUBLIC MEETING WITH CASELLA (WASTE MANAGEMENT)

A public forum with representatives from Casella was held in the Enfield Community Building on February 11 (Monday). The purpose of this informational session was to provide Casella representatives an opportunity to share important information about their curbside rubbish and recyclables collection practices, and also give Enfield residents an opportunity to pose questions or concerns that could help Casella improve the quality of their service to our community. The meeting was well-attended and we appreciate the amount of input provided by residents. A follow-up survey is being considered. The Town is committed to providing high-quality services and meeting the needs and expectations of Enfield residents. 
STRATEGIC PLANNING & GOVERNANCE

In March 2018, with strong community support, Enfield town officials began working with the Center for Strategic Governance (www.strat-gov.com) to adopt strategic governance to help leaders and residents create a desired future.

Strategic governance consists of two related ongoing efforts. The first engages residents and officials in deciding what matters most to their community and in envisioning a desired future that achieves those outcomes. This is strategic thinking; it helps people decide *what* to achieve. The second involves making that vision a reality by achieving strategic initiatives while managing day-to-day operations. This is operational governance; it focuses on *how* to achieve desired outcomes.

A Framework for Strategic Governance

Engaging Citizens to Envision and Achieve a Desired Future





A Proposed Vision:

Retain Enfield's town character, sense of community, environment, and heritage, because residents generally like the town as it is.

Priorities

Improve the following aspects that shape our quality of life:

- 1. **Financial Condition/Affordability** Strengthen Enfield's finances (build reserves, eliminate operating deficits, smooth tax rates; improve cash flow, release more TIF District funds for TIF projects; secure \$1million by 2022 in external grant funding, and increase the amount of non-property tax revenue (NPTR) by at least 2% annually through 2023.
- 2. **Public Health & Safety** Fire and EMS are not functioning as effectively or efficiently as they should or could. Issues seem to fall under the categories of staffing and management. Explore whether Enfield might benefit from a merger of the two into a Fire-Rescue department.

3. Infrastructure, Facilities and Technology

- a. Buildings/Facilities Most departments cite that substandard buildings/facilities limit fulfilling their mission. They have asked for \$296,500 in upgrades over the next five years that still won't create truly effective space. Through a Municipal Facilities Optimization Study to be completed soon, we are identifying costs for either building a new municipal complex with enough shared space to serve all departments or completing major designs and renovations to existing Town buildings.
- b. Water System A Water Asset Planning/Management Study funded with a DES matching grant will tell us in the coming months whether DPW will need to rebuild some or all of the 10-mile long water supply system originally built in 1903. The effort could cost \$3 million in today's dollars. We're also analyzing the existing water rate structure to ensure that the Town's fees are fair, equitable, and financially sustainable.
- c. Wastewater System We are launching an analysis of our wastewater assets (including ways to reduce stormwater/groundwater infiltration), a rate study to ensure that user fees are promoting financial sustainability within the Sewer Fund, and a feasibility analysis of constructing and operating our own municipal wastewater treatment plant. This should be completed by Spring 2019.
- 4. **Community/Economic Development and Housing** Enfield has been slow to create or adequately explore the viability of many community/economic development ideas that have been raised over the past years. The Community/Economic Development function needs to provide leadership at the municipal level; engage the Enfield Village Association and others interested in making progress; and increase the level of effective support for the Planning Board as it works on the Master Plan and any proposed updates to the Town's Zoning Ordinance.

 to accept petitions to amend zoning ordinance, historic district
 ordinance or building code for consideration at the 2019 town meeting.
 [RSA 675:4 90 days before town meeting]
- Wednesday, January 23, 2019
 First day for candidates in towns with non-partisan official ballot system to file declarations of candidacy with town clerk. [RSA 669:19; 652:20 seventh Wednesday before town meeting]
- Friday, February 1, 2019
 Last day for filing declarations of candidacy with town clerk in towns with non-partisan official ballot system. Town clerk's office must be open at least from 3 to 5 p.m. [RSA 669:19; 652:20 the Friday next following the first day for candidates to file declarations of candidacy on 1/23/19]
- Tuesday, February 5, 2019
 Last day for 25 or more voters or 2% of the total, whichever is less, but in no case fewer than 10 voters, to petition select board to include an article in the warrant. [RSA 39:3 fifth Tuesday before town meeting]
- Saturday, March 2, 2019
 Last day for town clerk to accept voter registration applications for town meeting day (Voters may register on election day for all town elections). [RSA 64:8; RSA 654:27, deadline for town clerk to accept voter registration is the same date as the date for the last checklist session correction the Saturday no less than 6 and no more than 13 days before town meeting]
- Saturday, March 2, 2019
 Supervisors to hold session for correction of checklist prior to annual meeting for no fewer than 30 minutes. No corrections or additions may be made after this session until election day, except as provided in RSA 659:12. [RSA 654:27; 654:28; 669:5; 40:13, II-d, VII]
- Tuesday, March 5, 2019
 Last day to submit zoning ordinance protest petition to require 2/3
 vote at town meeting. [RSA 675:5- at least 7 days before town meeting]

 The town clerk's office shall be open to receive applications for absentee ballots, to provide voters the opportunity to complete absentee ballots, and to receive returned ballots on the Monday immediately prior to an election at a minimum from 3:00 p.m. to 5:00

p.m. The clerk may designate a deputy clerk or assistant to provide this service, provided the individual has taken the oath of office and has been trained in the requirements for using an absentee ballot and the procedures for issuing and receiving absentee ballots. [RSA 657:1, II (c)]

DEPARTMENT OF PUBLIC WORKS

Toters

The trash and recycling toters are part of the Enfield trash and recycling collection program and must remain with the property upon a property transfer. The Town has had to replace many of these containers that people have taken with them after selling their properties.

Recycling Fees

The Town of Enfield charges fees for items that the Town gets charged for to dispose of including CFC units, tires, TVs, computers, tires, electronics, fire extinguishers, propane tanks and microwave ovens. Lately a number of people have been trying to "sneak" items into the Transfer Station to avoid paying these fees. It is very important to dispose of these items properly not only to the health of the Town budget but the safety of the operators and

people at the Transfer Station and down the trash and recycling streams. Many of these items contain hazardous materials which is the reason for the fee. Hiding hazardous materials in bags going into a compactor or placing them in the metal container that will be run through a grinder could result in a serious injury. Enfield Vegetative Management Facility

The Enfield Vegetative Management Facility closed on November 3, 2018 and will reopen May 1, 2019. Clean brush and yard waste can be recycled at Hammond's Grinding and Recycling just East of Canaan Village on US Route 4. 603-523-4353 and the Lebanon Landfill will take brush and yard waste year-round.

Construction and Demolition Material (C & D)

The Enfield Transfer Station and Enfield Vegetative Management Facility do **NOT** accept any volumes of C & D at this time. These materials are accepted, for a fee, by the Lebanon Landfill 370 N Plainfield Rd, West Lebanon and Hammond's Grinding and Recycling just East of Canaan Village on US Route 4.

Water Saving Tips to Help You Save Money on Your Next Water/Sewer Bill

- **1.** Check faucets and pipes for leaks. A small drip from a worn faucet washer can waste 20 gallons of water per day. Larger leaks can waste hundreds of gallons.
- **2.** Check your toilets for leaks. Put a little food coloring in your toilet tank. If, without flushing, the color begins to appear in the bowl within 30 minutes, you have a leak that should be repaired immediately. Most replacement parts are inexpensive and easy to install.
- **3.** Use your water meter to check for hidden water leaks. Read the house water meter before and after a two-hour period when no water is being used. If the meter does not read exactly the same, there is a leak.
- **4.** Install water-saving shower heads and low-flow faucet aerators. Inexpensive water-saving low-flow shower heads or restrictors are easy for the homeowner to install. Long, hot showers can use five to ten gallons every unneeded minute. "Low-flow" means it uses less than 2.5 gallons per minute (gpm). Also, all household faucets should be fit with low-flow aerators. 2.5 gpm may be needed in a kitchen sink but bathroom faucets and other water outlets should be 1.5 gpm or lower. Check gpm rating on packaging to be sure the advertised "low-flow" is

- at or below these levels. This single best home water conservation method is also the cheapest!
- **5.** *Insulate your water pipes.* It's easy and inexpensive to insulate your water pipes with pre-slit foam pipe insulation. You'll get hot water faster plus avoid wasting water while it heats up.
- **6.** Take shorter showers. One way to cut down on water use is to turn off the shower after soaping up, then turn it back on to rinse. A fourminute shower uses approximately 20 to 40 gallons of water. Limit your showers to the time it takes to soap up, wash down and rinse off.
- **7.** Turn off the water after you wet your toothbrush. There is no need to keep the water running while brushing your teeth. Just wet your brush and fill a glass for mouth rinsing.
- **8.** *Rinse your razor in the sink.* Fill the sink with a few inches of warm water. This will rinse your razor just as well as running water, with far less waste of water.
- 9. Use your dishwasher and clothes washer for only full loads. Automatic dishwashers and clothes washers should be fully loaded for optimum water conservation. Most makers of dishwashing soap recommend not pre-rinsing dishes which is a big water savings. With clothes washers, avoid the permanent press cycle, which uses an added 20 liters (5 gallons) for the extra rinse. For partial loads, adjust water levels to match the size of the load. Replace old clothes washers. New Energy Star rated washers use 35 50% less water and 50% less energy per load. If you're in the market for a new clothes washer, consider buying a water-saving frontload washer.
- **10.** Keep a bottle of drinking water in the fridge. Running tap water to cool it off for drinking water is wasteful. Store drinking water in the fridge in a safe drinking bottle.

Please Use Curbside Trash and Recycling Services

Trash and Zero Sort recycling collected at the Transfer Station cost the Town of Enfield significantly more per ton than trash and recycling collected curbside due to extra hauling charges. Trash collected at the Transfer Station costs approximately \$30 per ton more than material collected curbside (when Transfer Station transportation fees are included). Zero-Sort recycling collected at the Transfer Station costs the Town over \$80 per ton more than recycling collected at curbside due to the extra hauling fees (when Transfer Station transportation fees are included).

PLANNING & ZONING OFFICES

The Planning Board held a public hearing on January 21 to finalize the proposed changes to the Town's Zoning Ordinance that will be voted on (official ballot) during the Town elections on March 12. The proposed changes to the Zoning Ordinance are as follows:

Article 2: Are you in favor of the adoption of Amendment No. 1 for the Town of Enfield Zoning Ordinance as follows?

Amend definition of "Setback" in Appendix A:

"The distance between a building or structure and the nearest property line, wetland, or sewage disposal system. Setbacks are to be measured from the drip line and include but are not limited to decks, roof overhangs, fireplaces, and any bump-outs on the structure."

Article 3: Are you in favor of the adoption of Amendment No. 2 for the Town of Enfield Zoning Ordinance as follows? Amend Section 413 Non-Conforming Lots and Uses:

- 2. Any non-conforming uses existing on the effective date of this Ordinance shall be considered a lawful let use and may be continued. Even though the lot where the use is located does not comply with the minimum lot size or frontage requirements, the let use may be continued built upon provided all other standards of the district in which it is located are met.
- 4. Last two sentences: The replacement uses (or buildings and structures, if applicable) must be in the same location, and the

same or less dimensions as before the damage. The dimensions include length, width, and height of the original structure.

Article 4: Are you in favor of the adoption of Amendment No. 3 for the Town of Enfield Zoning Ordinance as follows?

Amend the definition of "Accessory Dwelling Unit" in Appendix A: A single apartment of no more than 800 square feet, containing no more than **two** one bedrooms and one bathroom, must be connected to a single family dwelling as defined in RSA 674:71-73 by enclosed weather-tight space with continuous roof and continuous foundation. The apartment accessory dwelling unit and main dwelling are exempt from district acreage density requirements and must remain under one ownership.

Article 5: Are you in favor of the adoption of Amendment No. 4 for the Town of Enfield Zoning Ordinance as follows?

Amend section 403 Special Exceptions to add "Kennels" to the following lists for provision of that use by special exception: Section 4. CB (Community Business District) and Section 6. Route 4 District.

Article 6: Are you in favor of the adoption of Amendment No. 5 for the Town of Enfield Zoning Ordinance as follows?

Amend Section 408 Signs, paragraph C:

- C. Signs shall refer only to a use, activity or business carried on the lot upon which they are situated, except that the Zoning **Administrator** Board of Adjustment may grant permission as a Special Exception for erection, off the premises, of a limited number of non-illuminated signs, providing the following conditions are met:
 - 1. Each sign not exceeding three square feet.
 - 2. Intended solely to give directional information.
 - 3. No more than three signs for any one business townwide.



There is something about the winter months and curling up with a good book by the fireplace. But did you know that heating equipment is one of the leading causes of home fire deaths? With a few simple safety tips and precautions you can prevent most heating fires from happening.

BE WARM AND SAFE THIS WINTER!

- Keep anything that can burn at least three-feet (one metre) away from heating equipment, like the furnace, fireplace, wood stove, or portable space heater.
- Have a three-foot (one metre) "kid-free zone" around open fires and space heaters.
- Never use your oven to heat your home.
- Have a qualified professional install stationary space heating equipment, water heaters or central heating equipment according to the local codes and manufacturer's instructions.
- Have heating equipment and chimneys cleaned and inspected every year by a qualified professional.
- Remember to turn portable heaters off when leaving the room or going to bed.
- Always use the right kind of fuel, specified by the manufacturer, for fuel burning space heaters.
- Make sure the fireplace has a sturdy screen to stop sparks from flying into the room. Ashes should be cool before putting them in a metal container. Keep the container a safe distance away from your home.
- Test smoke alarms at least once a month.

Heating Equipment Smarts

Install wood burning stoves following manufacturer's instructions or have a professional do the installation. All fuel-burning equipment should be vented to the outside to avoid carbon monoxide (CO) poisoning.

When the weather turns cold, it can bring a chill into our homes. Portable space heaters have become a popular way to supplement central heating or heat one room. If you plan to use portable electric space heaters, make sure to follow these tips and recommendations:

HEATER CHECKLIST

- Purchase a heater with the seal of a qualified testing laboratory.
- Keep the heater at least 3 feet (1 metre) away from anything that can burn, including people.
- Choose a heater with a thermostat and overheat protection.
- Place the heater on a solid, flat surface.
- Make sure your heater has an auto shut-off to turn the heater off if it tips over.
- Keep space heaters out of the way of foot traffic.
 Never block an exit.
- Keep children away from the space heater.
- Plug the heater directly into the wall outlet.
 Never use an extension cord.
- Space heaters should be turned off and unplugged when you leave the room or go to bed.

Types of electric space heaters

Oil or water-filled radiator Heated oil or water travels through the heater.

Fan-forced heater


A fan blows warm air over metal coils.

SMOKE ALARMS ARE A KEY PART

of a home fire escape plan. When there is a fire, smoke spreads fast. Working smoke alarms give you early warning so you can get outside quickly.

SAFETY TIPS

- Install smoke alarms in every bedroom. They should also be outside each sleeping area and on every level of the home. Install alarms in the basement.
- Large homes may need extra smoke alarms.
- It is best to use interconnected smoke alarms.
 When one smoke alarm sounds, they all sound.
- Test all smoke alarms at least once a month.
 Press the test button to be sure the alarm is working.
- Current alarms on the market employ different types of technology including multi-sensing, which could include smoke and carbon monoxide combined.
- Today's smoke alarms will be more technologically advanced to respond to a multitude of fire conditions, yet mitigate false alarms.
- A smoke alarm should be on the ceiling or high on a wall. Keep smoke alarms away from the kitchen to reduce false alarms. They should be at least 10 feet (3 meters) from the stove.
- People who are hard-of-hearing or deaf can use special alarms. These alarms have strobe lights and bed shakers.
- Replace all smoke alarms when they are 10 years old.

FACTS

- A closed door may slow the spread of smoke, heat, and fire.
- Smoke alarms should be installed inside every sleeping room, outside each separate sleeping area, and on every level. Smoke alarms should be connected so when one sounds, they all sound. Most homes do not have this level of protection.
- Roughly 3 out of 5 fire deaths happen in homes with no smoke alarms or no working smoke alarms.
