# MASCOMA LAKESIDE PARK - UPDATES

After officially purchasing the property from the NH Department of Transportation in March 2019, the Mascoma Lakeside Committee's focus has been on raising additional funds for amenities for the park. This past fall we actively solicited public input through a series of meetings with local organizations, town committees, and a well-attended public forum held at the Community Building. The top priority for all stakeholders is that the natural beauty of the site be preserved and not over-developed. Some improvements are also needed and desired. They include removing and replacing brush and trash trees with native shrubs and trees; creating trails and educational signage to enhance recreational use of the property; constructing rainwater gardens and a new retaining wall to protect the water quality of the lake;

installing a children's wading/swimming area; improved parking; installing grill boxes, and; building an open pavilion (which will likely include a fire feature of some sort) that can serve as a gathering place and an educational facility.

Members of the Mascoma Lakeside Committee would like to extend their



appreciation to local architect Paul Mirski, who has been graciously providing valuable design services and consultation in support of this project at <u>no cost</u>. The committee will continue working closely with Mr. Mirski and others to ensure that the park is ultimately designed and developed in a manner that is consistent with the needs and values of our residents and visitors.

Although the committee has officially raised the additional \$135,000 in private funds needed to match (dollar for a dollar) a \$135,000 matching grant from the Northern Borders Regional Commission to help fund improvements to the park property (which is a major achievement), private fundraising efforts are still needed to ensure that we have the financing required to complete all the planned improvements.

# **CEMETERY SEXTON – HELP WANTED**

The Town of Enfield's Cemetery Trustees are in search of a sexton. This is currently a volunteer position, but has the potential to become a paid position in the future. Given the nature of the position, it is important that the sexton be a conscientious, organized and empathetic individual. The cemetery sexton responsibilities include the following:

- Coordinating tasks associated with burials with funeral directors, families and any others involved
- Being available at odd hours if necessary, to accommodate plot owners or buyers
- Maintaining and updating records of burials and plots

- Researching inquiries from the public regarding family members burial locations and historic context
- Explaining burial and plot sale requirements to the public
- Selling plots
- Participating in monthly meetings of the Cemetery Trustees
- Reporting sales to the Cemetery Trustees and other town bodies as appropriate
- Working with members of the Town's Public Works Department to open and close graves, and sow grass
- Receiving burial fees and permits from funeral directors and ensuring permits and other forms of documentation are appropriately recorded with the Town

# TOWN-WIDE REVALUATION UPDATE

The Assessor's office is completing the revaluation in Enfield with the expectation of bringing assessments to 100% based on current market conditions. We are bound by the New Hampshire Constitution to "value anew" every five years, with the last revaluation taking place in 2014. We expect to send a letter to each taxpayer with the new and old value for comparison purposes. It will not be unusual to see your assessment change by 10%-15% as our assessments were generally below market value. Yes, there will be some assessments that may seem like sticker shock, but we do not set the market, the buyers and sellers set the market. When the total taxable grand list goes up the tax rate generally goes down. The Assessor's office does not set the tax rate, that is done based on a combination of the Town, School, County and State budgets which are voted on by either the citizens or legislative bodies. The assessments are just the means to fairly and equitably distribute the monies needed to fund those various governmental bodies.

In the letter there will be instructions on how to find the details about the new assessments including a report of the sales used to base values on, the old and new assessments. As of this writing, we expect to mail the notices Mid-September and hold informal reviews the end of September. Further details to follow on firm dates and times. Phone appointments will be available for those who will be out of town or cannot attend in person. In any case we ask that you review the data we post on-line before either scheduling an appointment or at a minimum before attending an informal review.

The information will be posted via a News link on the front page of the website <a href="www.enfield.nh.us">www.enfield.nh.us</a> which will bring you to the "2019 Revaluation" page, where reports and additional information will be available.

As far as the values are concerned there will be properties that go up, down or stay about the same. This is common in all revaluations because different classes of property increase or decrease in value at different rates. Where sales were minimal in certain classes or types of property, we looked back at sales that occurred after the last revaluation for more data points. As an Assessor, the more data you have the more reliable the assessments will be.

We encourage you to review the information and reach out to us if you have any questions as to how it might have affected you. It is never too late to consider additional information.

In addition to the revaluation project we converted our assessing software to a new system called "Avitar". Avitar is a New Hampshire based software company with installs in some 150 communities in New Hampshire. What this means is the property record cards will look different but will still have all the pertinent information about your property. As always, our door is always open so feel free to ask if you have questions.

# **Median Ratio History**

2018 - 95.2% 2017 - 95.4% 2016 - 99.3% 2015 - 96.4%

The Ratio of the relationship between qualified/bonified sales and their assessment is displayed as a median average. As an example, an assessment of \$180,000 divided by a sale price of \$200,000 yields a ratio of 90%.

Kris McAllister, Julie Huntley and I make up the professional assessing staff. If you are not familiar with the assessment program here in Enfield I have been in Enfield as the contract assessor since 1988, over 30 years. I have performed 5 previous revaluations here in that time. The other Assessor is Kristen McAllister who has assisted me for 12 years. Combined, we have 56 years of experience performing assessing work and are certified at the highest level obtainable in the State of New Hampshire. Enfield's Assessing Administrator is Julie Huntley who has worked in assessing since 1988 is certified as a Property Assessor's Assistant which requires both experience and coursework.

Recently there has been some public discourse reported in the Valley News concerning the purported actions of the Hanover Assessing program. Accusations include what is termed sales chasing, spot assessing and inaction

on the part of the Assessor. Whatever the allegations may be, we the assessors for Enfield will address your assessment concerns in a timely, respectful fashion. It is our duty to do so. We use sales to establish the market values so yes, these sales are going to dictate the new assessments and other similar properties will be adjusted similarly. This is what we are required to do. We use the Multiple Listing Service (MLS) to aid us in discovering changes or ratings of properties as we do not regularly get to see the inside of properties and most properties see changes either prior to the sale or immediately after the sale. It is unfortunate, but the legislature took the tool of required interior inspection of property away from Assessors several years ago.

We work for you the taxpayers and citizens of Enfield and are always available to discuss your concerns. Our job is to administer the property tax in the fairest possible way. We take our responsibilities very seriously and are totally invested in producing credible assessments. We hope for your continued support in the job we must do and please be patient during the informal review process as it always a trying time. We will address all your concerns in as timely a fashion as we can.

# MUNICIPAL FACILITIES EVALUATION PROJECT - CONCEPTUAL DESIGN & COST ESTIMATION

The 9-member Municipal Facilities Advisory Committee (MFAC), which was assembled this past spring to begin addressing the next phase of a comprehensive municipal facilities optimization study, has been meeting regularly and working diligently toward consensus-based recommendations. As was previously reported, the committee has completed detailed site visits to Enfield's existing municipal facilities to better understand current issues, limitations, strengths, challenges and opportunities associated with each facility. The committee has also taken part in a series of site visits to municipal facilities (town halls, public safety facilities and libraries) in other communities for comparison purposes and to better understand the pros and cons of different design options.

The MFAC is now evaluating the merits of various alternatives. These alternatives will range from relatively modest upgrades or alterations to existing facilities, to more extensive (re)construction options. The Town has issued a related request for qualifications (RFQ) to architecture and design firms to develop sufficiently detailed conceptual designs and associated cost estimations. Committee meetings are open to the public and meeting minutes are posted online (https://www.enfield.nh.us/municipal-facilities-advisory-committee).

Over the course of the coming weeks and months, in close coordination with the selected architecture and design firm, the MFAC will develop formal recommendations that are ultimately presented to the Board of Selectmen. These recommendations will be intended to enable the Town facilities to meet their service delivery needs in both the mid- and long-term while still ensuring that potential investments in new projects reflect fiscal responsibility and use external funding sources (i.e., federal and state grants) to the fullest extent possible in order to minimize the Town's financial commitment.

# **Public Works Projects**

# Inter-municipal Sewer Agreement with Lebanon

The Town of Enfield and City of Lebanon have completed negotiations on the draft inter-municipal agreement (IMA) for sewage collection and treatment services. Although there were some minor modifications that benefitted the City of Lebanon, there were others that will ultimately benefit Enfield. As such, the adjustments balanced each other out and the result is a mutually agreeable and equitable IMA that will preserve the Town's ability to potentially disconnect from Lebanon's sewer system if it were financially more advantageous to construct and operate our own local wastewater treatment plant in the future. The feasibility of constructing a local wastewater treatment plant is the focus of an engineering study the Town recently commenced using funding from the NH Department of Environmental Services.

# **Roadside Mowing**

The Enfield Highway Department will be finishing up mowing roadsides and easement areas in early September. This helps keep drainage areas open for flowing water and allows for snow storage. It also improves site distances making roads safer. Please use caution when approaching and passing the mower tractors as debris sometimes flies out from the mower heads and operator focus is on the ditch lines being mowed. Residents should mark shrubs that they do not want cut.

# NH Route 4A Sewer Connections and Fees

In late-July, the Town of Enfield hosted an informational meeting for property

owners that are interested in connecting to the recently completed sewer pressure main that extends from Shaker Village to the Lakeview Condominium complex. Topics covered included the financial, ownership, location, technical, maintenance and permitting aspects of connecting to the Enfield Sewer System. During this meeting, residents provided a wide range of useful feedback. The Town Manager and Board of Selectmen subsequently expressed support for holding additional meetings among appropriate town officials, representatives from the Lakeview Condo Association, and other property owners along the NH Route 4A corridor. # **Road Grading**

The Town Highway crew will be grading gravel roads throughout the summer. Motorists are urged to use caution when driving through these moving work zones often with three or four working pieces of equipment.

# July Storm Damage and Mitigation Update

On August 15, President Trump declared a Major Disaster in New Hampshire for the July 11-12, 2019 Storms in Grafton County. DR 4457 allows for Public Assistance in Grafton County and Hazard Mitigation Statewide. FEMA is in the process of setting up Applicant Briefings to go over the disaster declarations in detail. Applicants have 30 days to submit a formal Request for Public Assistance (RPA) from the date of declaration, and Enfield has been diligently collecting data over the past two months.

# Enfield Punch Cards & Lebanon Punch Cards

Enfield is instituting a punch card system, <u>effective September 4, 2019</u>, for the disposal of items for which a fee is assessed at the Enfield Transfer Station & Recycling Center. Enfield punch cards cost \$25 and can be punched up to 5 times in \$5 increments. Enfield punch cards or checks only—NO CASH—will be accepted at the Enfield Transfer Station for disposal fees. Enfield punch cards do not expire.

Lebanon punch cards are required for disposal of items at the Lebanon Landfill. Lebanon punch cards cost \$15 and can be punched up to 10 times. Each punch is currently valued at \$1.50 or 30 lbs. of trash (some exceptions apply) (subject to change).

Enfield and Lebanon punch cards can be purchased with cash or check made payable to 'Town of Enfield' at the Enfield Town Offices, 23 Main Street, during regular office hours—they will not be sold at the Enfield Transfer Station & Recycling Center. Lebanon punch cards are also available at select Lebanon locations for a small additional fee. # Construction and Demolition (C&D) Waste

The Lebanon Landfill is taking construction and demolition (C&D) waste once again for a fee of \$150/Ton. The other options available for these materials:

- Casella at their transfer facility located at 40 N Labombard Road, Lebanon, NH.
- Hammond's Grinding and Recycling located at 11 Hammond's Way Canaan, NH.

All three take commercial and residential volumes and charge fees. Residents with C&D to dispose of should call the facilities to be sure the items they wish to dispose of are accepted by the facility and what the fees are.

# **Enfield Water and Sewer Bills**

Enfield Water and Sewer bills were mailed out the second week of July and were due August 16, 2019.

# **Brush and Yard Waste**

The Enfield Brush and Yard Waste Facility will be open during the business hours of the DPW or Transfer Station Monday through Saturday. The facility is closed on Sundays. The facility can take clean brush and limbs up to 8" and leaves and yard waste. The Town cannot take any invasive plant species, stumps or dimensional lumber. Residents wishing to use the facility must have a valid Town sticker and stop at the DPW office or, on Saturday, at the Transfer Station to have all loads checked by Town staff. The facility cannot take commercial volumes.

Please Use Curbside Trash and Recycling Services
Trash and Zero-Sort recycling collected at the Transfer Station costs the Town of Enfield significantly more per ton than trash and recycling collected curbside due to extra hauling charges. Trash collected at the Transfer Station costs approximately \$30 per ton more than material collected curbside (when Transfer Station transportation fees are included). Zero-Sort recycling collected at the Transfer Station costs the Town over \$80 per ton more than recycling collected at curbside due to the extra hauling fees (when Transfer Station transportation fees are included).
Please do your part to <u>help keep our solid waste expenses down (and keep property tax rates as low as possible in the process)!</u>

hazardous to your health—don't even think about removing it yourself! Automotive batteries: Take to parts store for cash back or your transfer station Empty aerosol cans: Can be recycled with scrap metal. Talk to your town. Fluorescent lights: May be taken at your town facility. Check with your town. Food Co-ops and Home Depot take may take CFLs (spiral bulbs), not tubes. Latex paint: Use kitty litter, sawdust, or shredded paper to dry out latex paint, then throw in your trash. Empty, dry metal cans may be recycled as scrap metal at your recycling facility. If it says "clean up with soap and water," it's latex. Medicine: See www.twinstatesafemeds.com for police stations taking meds. Medical sharps: Place in a rigid container (e.g. detergent bottle), seal cap with duct tape, and label container with marker, "Sharps, not for recycling." Dispose of with regular trash by handing to a waste collector. See www.nh.gov/medsafety. Can drop off at Lebanon Police Station. Propane or helium tanks and fire extinguishers: Propane/helium tanks can be exchanged/refilled at a distributor; or contact town transfer station about empty tanks. Empty fire extinguishers can be recycled (NRRA takes from towns). Used motor oil: Take to town transfer station or a service station for recycling.



# FIRE DEPARTMENT

Well, summer is coming to an end sooner than we would all like. The kids are back to school, and the beach days are coming to a close.

Though we don't want to think about it, we are rapidly approaching the heating season. If you haven't done it already, now is a great time to schedule chimney cleanings and heating equipment service. Don't wait until it is too late, and make sure to get it done. Though we enjoy visiting with all our residents, we don't want to see you because you have a chimney fire or other issue at your home. These are easily preventable with proper cleaning and maintenance.

We continue to train at least once per month. In September, we will be training on auto extrication along with the ambulance to get ready for the upcoming winter accident season. We will also be training on chimney fire response.

The main fire engine in the Union Street station, which is now 18 years old, will be going out for a major pump repair in the coming weeks. This will be several thousand dollars. The engine from the Enfield Center station will be relocated to Union Street for the period in which it is gone. Also, some corrosion was discovered on one of the trucks that will need repair before it is due for inspection. Both of these expenses were not budgeted in 2019, but we are limiting other expenses as we can to try and stay within budget.

We have replaced a lot of protective equipment in the last few weeks. Helmets, boots and protective clothing that were expired were replaced. Moving forward, there will be a scheduled replacement cycle to limit spikes in the budget.

We want to remind you to keep an eye out for kids walking on and waiting by the road for buses now that school is back in session. Speaking of school being back in session, members of our department enjoyed assisting the Police Department with the 2<sup>nd</sup> annual "Walk with a Cop" on the first day of school.

As always, we are here when you need us. Have a great fall.

# PLANNING & ZONING OFFICES

Coming up in September the Zoning Board of Adjustment (ZBA) will hold three hearings for Zoning Variance applications. This meeting will be held on September 10<sup>th</sup> at 7:00 pm at the DPW facility at 74 Lockehaven Road. You may view the agenda for this meeting <a href="here">here</a>. The ZBA is still seeking some volunteers to serve as alternate members of the board. Interested persons should contact Rob Taylor, Land Use & Community Development

Administrator at 603-632-4067 ext. 5427.

The Planning Board has designated their first meeting of the month (on the second Wednesday) as a work session to make progress on the Town's Master Plan Update. These meetings will be open to the public, but will not include any hearings or conceptual discussion for projects. These early discussions have centered on defining the process and deciding where to begin. The September 11<sup>th</sup> meeting (7:00 pm at the DPW facility) will include a presentation from a potential consultant and discussions about the "scope of work" to be considered.

A lot of questions that come to the Land Use office relate to water bodies (lakes, ponds, rivers, streams, wetlands, etc). The Town's Zoning Ordinance (link to the Zoning Ordinance) has specific limitations with regard to waterfront development such as setbacks and usage restrictions. It is important to note that the State of NH has its own set of regulations when a project is in proximity of up to 250' to water. These regulations are contained in what is known as the Shoreland Program. There is a wealth of information on this subject on the State of NH- Department of Environmental Services (DES) website, which can be accessed here:

It is imperative that any project or work being considered or undertaken be fully compliant with both the Town of Enfield's Zoning Ordinance and the State of NH Shoreland Program requirements. Greetings all! September is a quiet month as water and sewer billings were due August 16th and the meter reading for the next quarter billing doesn't happen until the end of this month. The next tax and betterment bills won't be issued until sometime in the 4th quarter. I just want to remind everyone of the Paperless Billing now offered for Taxes, Betterments and Water/Sewer bills. You can sign up on line and then you will receive up to 3 email notifications from which you can click and link and pay the bill. As always, any and all of these bills are viewable and payable 24/7 online at www.enfield.nh.us. Payments made by electronic check on line have an additional flat fee of 95 cents. Payments by credit card have an additional fee of 2.95%. To make a payment online, from the home page, click on the online payments button and this will transfer to a new screen of options. Click on Tax Collector online payments and just follow the instructions from there. (Hint: when searching, use as few words as possible, such as house number and road name. Refrain from using St, Rd, Ave, Lane, etc.) Or just enter your last name and a list of possible answers will show on the right of the screen.

As a reminder, payments for taxes or utilities over the counter may be made by cash or check only.

# FINANCIAL POLICIES ADOPTED

At its July 15 business meeting, the Board of Selectmen reviewed and adopted a set of financial policies that were prepared by the Town Manager to help guide the Town toward ever greater fiscal responsibility. A complete copy of each policy is posted on the Town's website here:

**Undesignated Fund Policy –** The purpose of this policy is to improve the Town's financial stability by protecting itself against emergencies and economic downturns. This policy is also designed to help the Town prepare for a financial emergency as well as contribute to continuity of financial operations allowing for the management of necessary operations and projects mitigating short term borrowing and interest charges. It is essential that the town maintain adequate levels of undesignated fund balance to mitigate financial risks that can occur from unforeseen revenue fluctuations, unanticipated expenditures, and similar circumstances. Fund balance ensures cash flow and liquidity for town operations. This policy sets guidelines for fund balance classifications, minimum undesignated fund balance reserves and the allowable uses of undesignated fund balance.

**Debt Management Policy -** The purpose of this policy is to establish the

guidelines for the issuance of debt by the Town of Enfield. Debt levels and the related annual debt service expenditures are important long-term obligations that must be managed with available short- and long-term resources. This policy also addresses the level of indebtedness that the Town can reasonably expect to incur without negatively effecting its financial position. Adherence to a debt management policy, along with the utilization of other sound and prudent financial practices and the Town's other financial policies, will assure the lending market that the Town is well managed and will meet its obligations in a timely manner.

**Capital Reserve Policy** – It is the position of the Town of Enfield (Town) that accumulating and maintaining capital reserves as part of its annual budgeting process is important for long-term sustainability. The Town is committed to maintaining reasonable cash balances (reserves) to help offset the costs of future capital projects and replacements. The Town believes that establishing and maintaining such reserves will assist the Town in taking advantage of the "pay as you go" philosophy as opposed to relying entirely or heavily on debt financing. As such, the Town will ultimately be able to minimize the costs related to borrowing and debt service.

**Fraud Policy** – The Town of Enfield (Town) is committed to the deterrence, detection and correction of misconduct and dishonesty. The discovery, reporting and documentation of such acts provides a sound foundation for the protection of innocent parties, the taking of disciplinary action against offenders up to and including dismissal where appropriate, the referral to law enforcement agencies when warranted by the facts, and the recovery of assets. The purpose of this Policy is to implement systems and procedures that aid in the prevention of fraud and support the Town's culture and environment of honesty and ethical behavior.

# FIRE/EMS TRANSITION PLANNING PROCESS

As has been previously reported, following a Town Meeting vote in support of Fire Department governance changes, the Town of Enfield has contracted with Municipal Resources Inc. (MRI) – a NH-based firm with decades of experience assisting municipalities in the areas of emergency services leadership and operations – to complete an in-depth transition planning process for the Town's fire and ambulance departments. MRI's consulting team came to Enfield in July for an official kickoff session that included meetings with municipal management, all three public safety chiefs (Fire, EMS, Police), the Board of Selectmen, and a larger group listening session with all members of the Fire and Ambulance departments. MRI returned to Enfield in August to facilitate a nominal group process with members of the Fire and Ambulance departments, as well as municipal management. In the near future, a Fire/EMS working

group will be formed to begin carrying out a number of consensus action items. The project is expected to be completed over a roughly 6-month timeframe, and the primary deliverables of the project are as follows:

- Conduct an analysis of the merits of merging fire/EMS into a joint fully integrated department
- Provide an overview of pros and cons of integration and make a recommendation reflective of industry best practice.
- Provide planning and implementation support relative to this organizational and service re-alignment.
- Work with Enfield Fire/EMS staff and transition team members to reshape organizational culture and generate buy-in pertaining to new organizational governance, structures and procedures.
- Provide perspective based on industry best practice and team experience.
- Track and reporting progress on action items.
- Provide electronic communication to identified stakeholders.

# TOWN POLICIES RELATED TO DOGS

We would like to remind everybody that Enfield has a leash ordinance. The rules require that dogs must stay on your property and that when out in public be on a leash or "under control of a handler." Under control is defined as the dog being in the immediate area of the owner and ensuring that the dog responds to commands. The town ordinance also requires that owners pick up after their dog if it defecates on property other than property owned by the dog owner. It should also be known that Town ordinances also prohibit dogs from Huse Park, Shakoma Beach and Shaker Ball Fields at all times.

On a related note, at its May 20 meeting, the Board of Selectmen deliberated on a proposal to "trial" allowing intact dogs in all three enclosures at the Shaker Field Dog Park on NH Route 4A. Intact dogs had been previously prohibited in all enclosures prior to a rule change in the spring of 2018 that allowed intact dogs to utilize one of the enclosures ("Ingrid's Park"). After reviewing information contained in scientific literature, examining dog park rules being used in dog parks across the United States, and receiving testimony from a number of interested parties, the Board of Selectmen ultimately voted to permit intact dogs (with the exception of female dogs in heat) into each of the enclosures on a one-year trial basis. The merits of making this temporary rule permanent will be evaluated at the conclusion of the trial.

### **Toters**

The trash and recycling toters are part of the Enfield trash and recycling collection program and must remain with the property upon a property transfer. The Town has had to replace many of these containers that people have taken with them after selling their properties.

# **Recycling Fees**

The Town of Enfield charges fees for items that the Town gets charged for to dispose of including CFC units, tires, TVs, computers, electronics, fire extinguishers, propane tanks and microwave ovens. Lately a number of people have been trying to "sneak" items into the Transfer Station to avoid paying these fees. It is very important to dispose of these items properly not only for the health of the Town budget but the safety of the operators and people at the Transfer Station and down the trash and recycling streams. Many of these items contain hazardous materials which is the reason for the fee. Hiding hazardous materials in bags going into a compactor or placing them in the metal container that will be run through a grinder could result in a serious injury. # Water Saving Tips to Help You Save Money on Your Next Water/Sewer Bill

1. Check faucets and pipes for leaks. A small drip from a worn faucet washer can waste 20 gallons of water per day. Larger leaks can waste

- hundreds of gallons.
- **2.** Check your toilets for leaks. Put a little food coloring in your toilet tank. If, without flushing, the color begins to appear in the bowl within 30 minutes, you have a leak that should be repaired immediately. Most replacement parts are inexpensive and easy to install.
- **3.** Use your water meter to check for hidden water leaks. Read the house water meter before and after a two-hour period when no water is being used. If the meter does not read exactly the same, there is a leak.
- **4.** Install water-saving shower heads and low-flow faucet aerators. Inexpensive water-saving low-flow shower heads or restrictors are easy for the homeowner to install. Long, hot showers can use five to ten gallons every unneeded minute. "Low-flow" means it uses less than 2.5 gallons per minute (gpm). Also, all household faucets should be fit with low-flow aerators. 2.5 gpm may be needed in a kitchen sink but bathroom faucets and other water outlets should be 1.5 gpm or lower. Check gpm rating on packaging to be sure the advertised "low-flow" is at or below these levels. This single best home water conservation method is also the least expensive!
- **5.** *Insulate your water pipes.* It's easy and inexpensive to insulate your water pipes with pre-slit foam pipe insulation. You'll get hot water faster plus avoid wasting water while it heats up.
- **6.** *Take shorter showers.* One way to cut down on water use is to turn off the shower after soaping up, then turn it back on to rinse. A fourminute shower uses approximately 20 to 40 gallons of water. Limit your showers to the time it takes to soap up, wash down and rinse off.
- **7.** Turn off the water after you wet your toothbrush. There is no need to keep the water running while brushing your teeth. Just wet your brush and fill a glass for mouth rinsing.
- **8.** *Rinse your razor in the sink.* Fill the sink with a few inches of warm water. This will rinse your razor just as well as running water, with far less waste of water.
- **9.** Use your dishwasher and clothes washer for only full loads. Automatic dishwashers and clothes washers should be fully loaded for optimum water conservation. Most makers of dishwashing soap recommend not pre-rinsing dishes which is a big water savings. With clothes washers, avoid the permanent press cycle, which uses an added 20 liters (5 gallons) for the extra rinse. For partial loads, adjust water levels to match the size of the load. Replace old clothes washers. New Energy Star rated washers use 35 50% less water and 50% less energy per load. If you're in the market for a new clothes washer, consider buying a water-saving frontload washer.
- **10.** Keep a bottle of drinking water in the fridge. Running tap water to cool it off for drinking water is wasteful. Store drinking water in the fridge in a safe drinking bottle.
