Old business:

Mr. Meagher moved to accept minutes Mr. Durocher seconded Vote was unanimous

Fred Cummings resignation

Mr. Meagher moved to respectfully and regretfully accept Mr. Cummings' resignation and to thank him for his previous service as a trustee for the cemeteries.

Mr. Durocher seconded Vote was unanimous

Mr. Durocher agreed to look into how the trustees recommend/appoint a replacement

Cemetery laptop

Ms. Labrie:

New laptop works well, but VPN isn't set up yet

Mr. Taylor:

SymQuest is working through a long list of issues

Overhauled town system, moving to cloud hosting, etc.

Cemetery Rules and Regulations

Ms. Labrie:

Latest Cemetery Rules and Regulations need to be updated on the website Scattering grounds rules should be added to the latest Rules and Regulations

All agree that it makes sense to consolidate scattering grounds rules with the latest Cemetery Rules and Regulations and update the website. Ms. Labrie to look into getting that done.

Ms. Labrie noted that it would be appropriate to put a link to the updated Rules and Regulations in town newsletter. All agreed, and Mr. Taylor said he would take care of it.

Rules on solar lights and other decorations

Mr. Meagher:

We should update the rules regarding solar lights Want to make it more broad Countryside is beginning to get cluttered

Mr. Durocher:

Have there been complaints?

Mr. Taylor:

A while ago Not so much recently

Mr. Durocher:

I don't have a strong opinion either way

Mr. Meagher:

Will go back at night

Mr. Meagher moves to table the discussion on solar lights and other decorations Mr. Durocher seconds

Vote is unanimous

Report on nearby municipalities pricing for burial and plots

Mr. Durocher

Enfield's current pricing is in line with neighboring towns Recommends no change to current price Possible changes to fee structure: Fee broken up into plot price and ongoing maintenance

Charge differently for resident and non-resident

Ms. Labrie:

Liked the idea of breaking up fee Noted that non-residents don't pay taxes Raised possibility of breaking up lot sizes

Mr. Durocher:

How many non-residents have been buried recently?

Mr. Taylor:

Estimated that roughly 30% of recent burials were of non-residents

Most from neighboring towns, grew up in town, or had some other immediate tie

All agree that it would be in the Trustees interest to look at sections in Countryside that might be considered for cremation-specific plots

Mr. Durocher moves to move up the time of the next meeting and hold it at countryside Mr. Meagher seconds Vote is unanimous

Mr. Taylor's update

Grounds department has no current staffing Currently covering responsibilities w/ town highway staff 2 jobs listed - Leader and groundskeeper 50 applicants, though many applicants from far away Interviewing in a week or so

Mr. Meagher inquired about the vinyl fencing that needed to be replaced at Follensbee

Mr. Taylor said it had been delivered, and that he would check to see if it's been replaced

Ms. Labrie's update

Following up on last meeting's discussion of the bushes at Countryside, she counted 26 that were in need of replacing. Agreed to get recommendations for bush replacement for next meeting Two lots sold in Countryside Burial scheduled for the 31st Two other burials in scheduled for Countryside, 1 cremation, 1 full

Mr. Meagher and Mr. Durocher agreed to add the following items on the agenda for next month's meeting:

Shrubs Scattering grounds Decorations rules Cremation lots

Mr. Meagher moved to adjourn the meeting Mr. Durocher seconded Vote was unanimous
