Dear Mr. Diessner,

Property owner Susan Weaver, 16 Bassy Lane, Map#22, Lot#13, is applying to install a pervious patio and walkway, total impact 2500sq ft. While reviewing the photos of the proposed project, there is concern about the amount of trees cut. There are visible two old cut stumps, and two recently cut stumps. Though not addressed in the application, there is concern that the point total in a 50 x 25 section is below the 25 point total that is required due to the removal of the trees in the waterfront buffer zone. The Commission would like to bring this to your attention to verify if necessary.
