- Plainfield approved signing the JPA last week.
- 11 communities have signed on
- Enfield's Town's lawyer is reviewing the Joint Powers Agreement.
- Kim Quirk will be Enfield's delegate with Jo-Ellen Courtney as alternate on the Board of Directors of CPCNH.

Next steps suggested time line: Kim Quirk provided draft timeline for proceeding once the JPA is approved

- Jan: Final draft of power plan
- Feb: Public hearing for Community Power Plan
- Mar: Town Mtg to vote on Power Plan
