- 1. Elaine Doe (409 & 411 US Route 4 Tax Map 37 Lots 13 & 13-1)

The Doe property has an approved right of way from 2004 that they would like to abandon and in its place formalize the shared driveway that exists to the back lot. The board said they would need to get the change memorialized in the deed and have it filed with County Office.

2. Chuck Currier of Enfield Land Company (2 Smith Pond Road Map 6 Lot 31)

The site plan for the Montcalm Golf Course was approved in 2000. They presented a conceptual drawing for the addition of a 54'X100' storage shed near the club house. After discussion with the board, the board requested a change in the original plan that would show the new proposed storage shed and a delineation of 1600' Conservation zone line on the plan. David Fracht also noted that the original plan needed to be fixed to show that the lot is in Enfield and not Grafton on the plan. Discussion of solar panels on the storage shed was also discussed and the applicant said they would look into the suggestion. The applicant's representative said they would try to get the changes done in time for an April hearing date.
