- 45 "change to". The board went through each one making notes, suggestions and
- 46 comments. It was decided that Administrator Taylor will compile these thoughts into a
- 47 "sample" ballot for discussion at the next PB meeting.

V. <u>NEW BUSINESS:</u>

- 49 Chairman Fracht presented two ideas to expedite processes of the Planning Board's
- work. The first was a concept for expediting minor subdivisions. This would require four
- 51 members of the Planning Board (a sub-committee and quorum of the Board) to review a
- 52 project. If any abutter objected and wanted a traditional review, the expedited process
- would cease and the process reverts to a traditional hearing. Another idea is to adopt a
- 54 "technical review panel" to review minor site reviews. This is a panel of town employees
- to hear a project outside of the Planning Board. After some discussion of these ideas,
- the Board felt that they (the Board) are not overburdened at this time so that there is not
- 57 much need for expediting minor subdivisions. There was some support for a technical
- 58 review committee concept.
