Permit by Notification: Scott Williams, Pathways Consultants, is applying for a expedited permit to replace a retaining wall, 35 Algonquin Rd, Vince Memoli.

Alan:

We appreciate you getting us on the agenda for the Conservation Commission hearing on November 1st at 7 p.m. As discussed, the following is intended to give you an overview of the project.

The project is located at 35 Algonquin Road in Enfield, NH, on property owned by Vince Memoli. The project involves the in-kind replacement of an existing failing concrete retaining wall along the Crystal Lake shoreline using precast concrete blocks. The new wall is approximately 75 feet long by 3.5 feet high by 2.5 feet wide, and includes a short return wall on the north end, and a 6foot wide graded ramp with return walls for access to the existing seasonal floating dock. Work will be performed "in the dry" during the winter lake drawdown period between November and December 2018. The project includes a total of 454 square feet (SF) of permanent/temporary impacts waterward of the ordinary high water line and within the NHDES wetland jurisdiction, encompassing 192 SF of permanent impacts related to the footprint of the new wall, and 262 SF of temporary impacts within the lake bed for temporary sediment and erosion controls. The wetland impacts qualify for a NHDES Wetlands Permit By Notification, and we would like the Conservation Commission to sign this application so that it qualifies for an expedited 10-day review period. The project also requires a NHDES Shoreland Permit By Notification for approximately 1,300 SF of temporary impacts landward of the ordinary high water line related to wall construction, access, and staging areas, but this application does not require Conservation Commission review. The project also includes temporary sediment and erosion controls during the work, and restoration of the disturbance areas.

We will provide copies of the application materials and design plans to you prior to the hearing date. We will also plan to bring extra copies of plans and materials to the hearing.

10/20/18: Wildlife observation station: Strickland and Theis finished stag one of the Wildlife observation station. They removed 50 Buckthorn saplings and a clump of Multi-flora Rose. Work was done in concordance with Shoreline Protection Act. All work was done by hand, roots and stumps were left in place. Specially made black plastic bags were placed on Buckthorn stumps to prevent resprouting. Theis grass seeded top of area. Phase II will be waiting until spring to view results. May expand invasive removal, and then place a bench or benches. Thanks to DPW who hauled off the invasive species.
