#### 2019 PROPERTY TAX RATE HAS BEEN SET

After coordinating with the NH Department of Revenue Administration over the past week or so, and working diligently to get all the new values logged into the assessing system following the conclusion of our 5-year revaluation that played out over the last several months, local officials were able to finalize the 2019 tax rate in late October. Bills will have a December 6 due date, which is the same as last year.

The total tax rate for 2019 will be **\$25.05**, which is a **\$1.36** (5.15%) <u>decrease</u> from the \$26.41 aggregate tax rate in 2018. The breakdown of the aggregate tax rate is as follows:

- Municipal \$7.33 (vs. \$7.53 in 2018)
- Local Education \$13.71 (vs. \$14.58 in 2018)
- State Education \$2.15 (vs. \$2.29 in 2018)
- County \$1.86 (vs. \$2.01 in 2018)

The municipal component of the tax rate in 2019 represents a roughly 2.7% *decrease* from the 2018 rate.

To give an example, if a resident owns property that was appraised at \$250,000 in 2018 and their property value increased to \$269,000 in 2019 (that would be a 7.6% increase, which reflects the town-wide average following the revaluation), then their total tax bill will have gone from \$6,602.50 in 2018 to \$6,738.45 in 2019 (\$136 increase or approximately 2% overall). Obviously households who saw their assessed value increase by more than the 7.6% town-wide average will see their total tax burden increase by more than 2% and, likewise, households who saw their assessed value either decrease or increase by less than the 7.6% town-wide average will see their total tax burden increase by less than 2% (it might even have gone down from last year). In essence, anyone whose home's assessed value either decreased or at least didn't increase by more than 5% from the 2018 value will actually pay less property tax in 2019 than they did in 2018. This is pretty good news from a "bottom line" perspective.

#### ENFIELD ENERGY COMMITTEE CHANGES COMING

Beginning November 26, 2019, the Energy Committee will begin meeting on the 4th Tuesday of each month at the Enfield Town Hall @ 6 PM.

Pending approval and appointment by the Enfield Board of Selectmen on November 4<sup>th</sup>, Jo-Ellen Courtney and Kurt Gotthardt will move from alternate positions to full members of the Energy Committee and Jo-Ellen Courtney will take on the role of Chair. Wendell Smith is recommended to the Selectmen for appointment as an alternate member.

The Board of Selectmen also approved the formation of a subcommittee of the Energy Committee, a Community Power Committee, to study Community Choice Aggregation and to develop a plan. Community Choice Aggregation allows a municipality to have more control over how and where electricity is purchased. The Town can procure power on behalf of the residents, businesses, and municipality by aggregating. There is an opt-out available.

The Community Power Committee will be working with local towns such as Hanover and Lebanon to develop the plans for Community Choice Aggregation.

#### MUNICIPAL FACILITIES EVALUATION PROJECT UPDATES

The Municipal Facilities Advisory Committee (MFAC) most recently met on October 28. The last several committee meetings have involved a deeper examination of the program and facility needs of the various municipal departments and review and initial discussion of various alternatives being conceptualized by Bread Loaf, the Middlebury (VT) based architecture firm that the Town if working with on this important project. Additionally, several potential sites for a public safety facility (which would house police, fire and EMS) are also actively being evaluated for their suitability.

As a reminder, MFAC meetings are open to the public and meeting minutes are posted online (<a href="https://www.enfield.nh.us/municipal-facilities-advisory-committee">https://www.enfield.nh.us/municipal-facilities-advisory-committee</a>).

In the coming weeks, we anticipate public forums will start being scheduled so

the MFAC can bring residents up to speed on the work that has been done to date, and so that Bread Loaf can facilitate discussions intended to better understand resident needs and preferences.

Over the course of the coming weeks and months, in close coordination with Bread Loaf, the Town's selected architecture and design firm, the MFAC will develop formal recommendations that are ultimately presented to the Board of Selectmen. These recommendations will be intended to enable the Town facilities to meet their service delivery needs in both the mid- and long-term while still ensuring that potential investments in new projects reflect fiscal responsibility and use external funding sources (i.e., federal and state grants) to the fullest extent possible in order to minimize the Town's financial commitment. A number of public forums will be organized during this time frame to promote transparency and accuracy of information being shared.

#### FIREFIGHTERS & EMERGENCY MEDICAL PERSONNEL RECRUITMENT

If you are interested in helping to protect and care for people in your community, the Town of Enfield's Fire Department and Ambulance Service welcomes the opportunity to talk with you. Both departments are "call" departments and participation requirements are flexible in recognition that members will be juggling other professional or personal obligations. Members are compensated on an hourly basis for time spent in training, responding to



calls, or other related activities. Relevant training and certifications (i.e., Firefighter I or II, EMR, EMT, AEMT, Paramedic, etc.) are highly desired, but formal training can be provided to individuals who are willing to make the commitment.

#### DEPARTMENT OF PUBLIC WORKS

#### Main Street Water Break

The Town of Enfield experienced a significant water break on Main Street in the vicinity of George's store on October 24, 2019 at 2:30 in the afternoon. The water was quickly shut down and repair operations started. The road was

closed for a significant part of the afternoon and evening. A detour was established on Blacksmith Alley to allow patrons to visit George's store. Two buildings on Main Street were without water until repairs were made. The hole was backfilled and the Town paved it. The site will be monitored for the next several weeks for settling. A big thank you to DR Key Corp, the Enfield Fire Department and Town staff all working together making the repairs and handling traffic.

# Winter Parking Ban

The Enfield Board of Selectmen wishes to remind citizens of Enfield that the Winter Parking Ban is in effect from November 1 through April 1.

No vehicle shall at any time be parked on any public or publicly maintained street, alley, roadway or way open to the public, in a manner that hinders in any fashion the maintenance of the way.

#### **Enfield Transfer Station Punch Cards**

In an effort to make the Transfer Station more efficient and also respond to deficiencies noted by the New Hampshire Department of Labor the Town of Enfield is implementing a punch card system that will take the place of all transactions by cash or check. Residents will purchase punch cards at the Town Office to be used to pay fees at the Transfer Station. Cards will have a face value of \$25.00 and attendants will have a hole punch tool that will be used to punch the cards for the corresponding amount of the item being disposed of. Each card is broken up into five \$5.00 sections and all of the fee items listed below are also in \$5.00 increments. The Transfer Station attendants accept cash through the month of October, but this practice will be discontinued starting in November. Checks will continue to be accepted for a period of time to give residents time to get to the Town Office to purchase the punch cards.

#### **Toters**

The trash and recycling toters are part of the Enfield trash and recycling collection program and must remain with the property upon a property transfer. The Town has had to replace many of these containers that people have taken with them after selling their properties.

# **Recycling Fees**

The Town of Enfield charges fees for items that the Town gets charged for to dispose of including CFC units, tires, TVs, computers, tires, electronics, fire extinguishers, propane tanks and microwave ovens. Lately a number of people have been trying to "sneak" items into the Transfer Station to avoid paying these fees. It is very important to dispose of these items properly not only to the health of the Town budget but the safety of the operators and people at the Transfer Station and down the trash and recycling streams. Many of these items contain hazardous materials which is the reason for the fee. Hiding hazardous materials in bags going into a compactor or placing them in the metal container that will be run through a grinder could result in a serious injury. # Please Use Curbside Trash and Recycling Services

Trash and Zero-Sort recycling collected at the Transfer Station costs the Town of Enfield significantly more per ton than trash and recycling collected curbside due to extra hauling charges. Trash collected at the Transfer Station costs approximately \$30 per ton more than material collected curbside (when Transfer Station transportation fees are included). Zero-Sort recycling collected at the Transfer Station costs the Town over \$80 per ton more than recycling collected at curbside due to the extra hauling fees (when Transfer Station transportation fees are included).

Please do your part to <u>help keep our solid waste expenses down (and keep property tax rates as low as possible in the process)!</u>

## **Enfield Speed Trailer**

Many pass the speed trailer set up on various streets around Town. The trailer

is more than a gentle reminder to watch you speed. The trailer provides valuable data to Enfield Departments including the Police, Highway and Planning. The trailer counts each vehicle that passes it and records the speed. This data will be used to assist in the allocation of highway funds and in hazard mitigation grants applications. The data also helps the Police address speeding concerns on individual streets.

# **Culvert Replacements**

The Enfield Highway Department will be replacing culverts on several roads that are required to be done during low water levels and /or during lake drawdown per the issued Wetlands Permit. Roads may be closed at these sites for part of the day. Signs will be placed to notify residents of closures.

#### Water and Sewer Bills

The Water/Sewer Department mailed third quarter bills the first week of October. Properties that changed hands during the third quarter may or may not have the new owners in the database. Please forward the bills to the new owners if known or to the closing attorney. The Town online bill paying application can be used for paying bills and checking balances due. https://www.enfield.nh.us/home/pages/online-payments

The Town is no longer sending bills to tenants. Owners are responsible for the payment of utility bills and are free to set up payment arrangements with their tenants that do not involve the Town.

# **Enfield Vegetative Management Facility**

The Enfield Vegetative Management Facility will be closing November 2, 2019 and will reopen May 1, 2019. Clean brush and yard waste can be recycled at Hammond's Grinding and Recycling just East of Canaan Village on US Route 4. 603-523-4353 or by landfill tickets at the Lebanon Landfill.

#### **Cemetery Decorations**

The Enfield Cemetery Ordinance requires that all cemetery decorations and flowers shall be removed by October 1<sup>st</sup> of a given year and can be reinstalled on May 15<sup>th</sup> of a subsequent year. Decorations remaining in Enfield Cemeteries after October 30<sup>th</sup> will be collected and disposed of.

#### LAND USE & COMMUNITY DEVELOPMENT OFFICE

Enfield's Planning Board has commenced in earnest with the Master Plan update process. A contractor, the Center for Strategic Governance, has been retained to initiate a "pre-planning" process for the Master Plan. The first step is attempting to identify specific "themes" that will guide the planning board for the next 12-18 months. These themes are essentially questions that will be answered through the work of Master Planning. Much has already been done by the Planning Board to refine these themes and focus on the proper details. An early first step will be to assemble a focus group of Enfield residents, to hear the themes and comment on them. This will help to determine if we are on the right track or if we need to add additional themes. The Planning Board has designated their first meeting of the month for Master Plan work and as always these meetings are open to the public. You are encouraged to get involved and to keep an eye out for upcoming special sessions to provide public input.

Along these lines, the Town of Enfield's Planning Board needs your help! Their goal is to assemble a "focus group" of up to 8 people for a two hour session on Saturday, November 9<sup>th</sup> from 10:00 am to 12:00 pm. If you are available to participate, please complete the survey by following the link below. In order to have the most diverse membership in this group, this survey asks you to tell us a little about yourself. Based on the responses to this survey, we will invite up

to 8 respondents, representing a "cross section" of Enfield to the focus group session. Important: If you are not available for Saturday, November 9<sup>th</sup> from 10:00 am to 12:00 pm, you should not complete this survey. If you are not selected for the first focus group, don't fret, as we will absolutely ask for your participation at subsequent master planning events. The deadline for responses is November 1, 2019 (today!). We appreciate your help!

The Planning Board held a major site plan review hearing on October 23 for an apartment building that is currently two units and is planning to be repartitioned into three apartments. Abutters were in attendance to hear details on the application. Some minor details of the project were fine tuned during the hearing. One of these had to do with lighting and this brings up a good point. If you have exterior lighting on your residence ask yourself the following questions: Does my light shine onto someone else's property? Can the light be made to activate with motion instead of being always on? Is my light providing real benefits or is it wasting electricity? The answers to these questions have a lot to do with being a good neighbor. Enfield's site plan regulations require "dark sky compliance." This means that lights are focused downwards and not up into the sky. Are your lights pointed in the right direction? The project was approved as presented.

Due to the Thanksgiving holiday, there will be no Planning Board meeting on November 27. There will be a major site plan review hearing on November 30 for MK Fine Cabinetry/ Matt Knittle who is constructing a 5000 square feet shop on Smith Pond Road (off I-89 Exit 15).

The Town is still seeking a recording secretary/ minutes taker for the ZBA meetings that occur on the second Tuesday of each month at 7:00 pm at the DPW training room. The position is offered at \$18/hour. #### OFFICE OF THE TAX COLLECTOR

Greetings all! Things are picking up in the Tax Office. The tax bills and sewer betterment bills should be out by early/mid November and due early/mid December. As a reminder, the 3<sup>rd</sup> quarter water/sewer bills are due November 15<sup>th</sup>.

For making any of these payments, utilizing the paperless billing option is strongly encouraged!

Some benefits of paperless billings are...

- Environmental no actual paper bill and thus no envelop necessary. No transportation required by any vehicle using gas, diesel or battery and saves wear and tear on our roads!
- No need to remember the due date. Three reminders are emailed! First email sent when bills are ready to pay (no need to watch for the postal carrier!), second email sent 10 days prior to the due date and the third email sent the day prior to the due date.
- If paid on line, an immediate email receipt of the transaction is sent so no worries about having to remember whether or not you actually made the payment or searching for a paper receipt. Payments made by electronic check on line have an additional flat fee of 95 cents. Payments by credit card have an additional fee of 2.95%.

- It's so easy to sign up for paperless billing by going to <a href="www.enfield.nh.us">www.enfield.nh.us</a>, online payments, enter your last name under owner and click the search button. Your name should appear on the right side of the screen. Choose you, add an invoice to cart and click on "check out". The very next screen will have a box to toggle stating "Yes, I am the Primary Owner for the parcel(s) I have selected and I want to sign up for Paperless Bill Notification." You will also need to enter your email address here.
- Cost savings-Paperless billing also helps to keep Town spending down by reducing printing, postage and production costs associated with mailing out the paper invoices.



Beginning January 2<sup>nd</sup>, 2020 the Tax Collector hours and the Town Clerk's hours will be changing to Mondays, Wednesdays, Thursdays and Fridays 8:30am to 3:30pm and Tuesdays will be 11am to 7pm. This better aligns with the State DMV office as they too have evening hours on Tuesdays.

#### Want to Donate to the Town's Fuel Assistance Fund?

The Town of Enfield's Human Services Department provides financial support

for fuel to Enfield residents in need. The funds we redistribute come from private donations made to a dedicated trust fund set up for this specific purpose. Our ability to help needy families with their fuel needs is, in large part, dependent on the monies available in the fuel



fund. We strongly encourage residents to consider making a donation to the fuel fund to help others in the community. Donations are tax deductible! For more information, please contact Diane Heed, Human Services Director, at 603-442-5429 or dheed@enfield.nh.us.

#### Information on the Tri-County Community Action Program (TCCAP)

Fuel Assistance Program

As funds become available, the Fuel Assistance Program provides benefits to qualified New Hampshire households to assist with heating costs. The Fuel Assistance Program can also help households during a heating emergency by securing an emergency delivery of fuel, delaying a shut-off notice or referring clients to another source of assistance. Fuel Assistance benefits are a grant and do not have to be paid back and can range from \$210 to \$1,575, depending on household income and energy costs. Benefits are calculated taking into account household income, energy costs, the number of heating degree days within a region and housing type. This targeting allows the Fuel Assistance Program to provide those households with the lowest incomes and highest energy costs with the highest benefits.

*Electric Assistance Program* 

The New Hampshire Electric Assistance Program (EAP) gives eligible customers

a discount on their monthly electric bills. The discount is from 8%-76% on your gross household income size and electricity usage. Customers of the following companies may apply for the discount:

- Eversource Energy
- Liberty Utilities
- NH Electric Co-op
- Unitil Energy Systems

#### Weatherization.

The Weatherization Program serves low-income households that are most vulnerable to high-energy costs and who do not have the means of making cost-effective energy conservation improvements to their homes.

TCCAP collaborates with the electric and utilities' energy efficiency programs to enhance the weatherization services provided to low-income households in New Hampshire whenever possible.

Weatherization crews in all three counties have made improvements in 378 single family homes and apartment units this year. As with Fuel Assistance, our clients qualify for services through a means-tested application process. Our crews not only make significant upgrades to the energy efficiency of a client's home but also tackle needed safety improvements. These services drive down the cost of heating people's homes and repair dangerous living conditions where they are found.

- Our holiday baskets provide warm clothing and a food certificate for a complete holiday meal.

#### FRIENDS OF MASCOMA UPDATES

The Friends of Mascoma Foundation has been accepted into the pilot round of a community crowdfunding project with The Local Crowd Upper Valley (TLC) and Vital Communities! We are a part of an amazing group of social enterprises that are building community and economy in the Upper Valley. We are excited to use TLC to increase community engagement and local investment.

As you may know, the Friends of Mascoma Foundation is committed to combating food insecurity in the Mascoma Valley Regional School District (MVRSD) through the Friends Feeding Friends program. The program operates two food pantries in Canaan and in Enfield, plus is the primary source of food and personal hygiene items for the pantry located inside Mascoma Valley Regional High School. Pantry shoppers can come once a week for a three-day supply of food. We have refrigeration, so we focus on fresh produce, meats and dairy products as well as non-perishables. We also supply food for snacks, backpacks, family food boxes as needed and other pantry items to the elementary and middle schools.

For the past several years a generous private donor has allowed us to use their vehicles, including a van and trailer, for food distribution. Use of these vehicles is essential to our Friends Feeding Friends program. The van has become a

beloved part of our work and has been dubbed 'Foodie' by everyone familiar with our work. Our Volunteers and Foodie travel to the New Hampshire Food Bank once a week. Foodie also travels to Price Chopper and Shaw's in West Lebanon and transports food to three different locations on a weekly basis. Foodie also helps transport food for school families during school breaks. This donor has also provided financial assistance for our Friends Feeding Friends program in other ways and while we are extremely grateful for their support, we are interested in both our organization's financial diversity and long-term sustainability. In other words: Use of these vehicles is essential to our Friends Feeding Friends program and it's time for us to get our own wheels! Participation in the TLC Upper Valley initiative through Vital Communities is an exciting opportunity for the Friends of Mascoma Foundation as we become more financially independent and continue to deliver our services to the community.

# **Base Lodge Updates**

As you may know, a 44' section of the lodge on the mountain side needs work to resolve the leaking and rot issue. On October 13th board members, community volunteers, and volunteers from <a href="MTD Building Contractors">MTD Building Contractors</a> spent the day doing demo work in the lodge. MTD completed interior bracing and on October 23rd, the wall was removed. The new wall will be framed over the next week. We have a tight timeline to complete the scope of work, but it will be done in time for opening day on December 13th!

#### The Local Crowd

Whaleback was selected to participate in a crowdfunding campaign through The Local Crowd Upper Valley, which is sponsored by Vital Communities. While the mountain side wall in the lodge is being re-framed, we are taking the opportunity to significantly improve the energy efficiency of the lodge by doing the following:

- Spraying foam insulation into a 44' section of the mountain side wall to air seal and increase the R-value
- Reconfiguring the entry vestibule on the mountain side wall to create a more effective air lock and reduce heat loss
- Installing energy efficient windows and doors in the new wall
- Installing LED bulbs in replacement light fixtures

The intent of this energy efficiency work is to become more environmentally friendly, improve comfort within the lodge, and reduce operational costs for the lodge. Our crowdfunding campaign launches on November 8th and we have a goal of \$10,000. Please stay tuned for more details and information on how to donate over the next couple of weeks.

We exceeded 3,200 patients about a month earlier than predicted, and we are still signing up 80 to 100 patients per month.

Our dental team, under Doctor Katie Takach, has openings for new patients for both general dentistry and for cleanings.

Our medical team is now fully staffed with the addition of Nurse Practitioner Karl Stanford (yes, one of our Mascoma High grads years ago) and Physician's Assistant Katrina DeShaney. They and Pediatrician Ben Gardner and Doctor Rick Weiss are taking new patients.

We service more health and dental insurance plans than any other primary care facility in the area.



#### MASCOMA LAKESIDE PARK - UPDATES

After officially purchasing the property from the NH Department of Transportation in March 2019, the Mascoma Lakeside Committee's focus has been on raising additional funds for amenities for the park. This past fall we actively solicited public input through a



series of meetings with local organizations, town committees, and a well-attended public forum held at the Community Building. The top priority for all stakeholders is that the natural beauty of the site be preserved and not over-developed. Some improvements are also needed and desired. They include removing and replacing brush and trash trees with native shrubs and trees; creating trails and educational signage to enhance recreational use of the property; constructing rainwater gardens and a new retaining wall to protect the water quality of the lake; installing a children's wading/swimming area; improved parking; installing grill boxes, and; building an open pavilion (which will likely include a fire feature of some sort) that can serve as a gathering place and an educational facility.

Members of the Mascoma Lakeside Committee would like to extend their appreciation to local architect Paul Mirski, who has been graciously providing valuable design services and consultation in support of this project at <u>no cost</u>. The committee will continue working closely with Mr. Mirski and others to ensure that the park is ultimately designed and developed in a manner that is consistent with the needs and values of our residents and visitors.

Although the committee has officially raised the additional \$135,000 in private funds needed to match (dollar for a dollar) a \$135,000 matching grant from the Northern Borders Regional Commission to help fund improvements to the park property (which is a major achievement), private fundraising efforts are still needed to ensure that we have the financing required to complete all the planned improvements.

The Town of Enfield's Cemetery Trustees are in search of a sexton. This is currently a volunteer position, but has the potential to become a paid position in the future. Given the nature of the position, it is important that the sexton be a conscientious, organized and empathetic individual. The cemetery sexton responsibilities include the following:

- Coordinating tasks associated with burials with funeral directors, families and any others involved
- Being available at odd hours if necessary, to accommodate plot owners or buyers
- Maintaining and updating records of burials and plots
- Researching inquiries from the public regarding family members burial locations and historic context
- Explaining burial and plot sale requirements to the public
- Selling plots
- Participating in monthly meetings of the Cemetery Trustees
- Reporting sales to the Cemetery Trustees and other town bodies as appropriate
- Working with members of the Town's Public Works Department to open and close graves, and sow grass
- Receiving burial fees and permits from funeral directors and ensuring permits and other forms of documentation are appropriately recorded with the Town

# Inter-municipal Sewer Agreement with Lebanon

The Town of Enfield and City of Lebanon have completed negotiations on the draft inter-municipal agreement (IMA) for sewage collection and treatment services. Although there were some minor modifications that benefitted the City of Lebanon, there were others that will ultimately benefit Enfield. As such, the adjustments balanced each other out and the result is a mutually agreeable and equitable IMA that will preserve the Town's ability to potentially disconnect from Lebanon's sewer system if it were financially more advantageous to construct and operate our own local wastewater treatment plant in the future. The feasibility of constructing a local wastewater treatment plant is the focus of an engineering study the Town recently commenced using funding from the NH Department of Environmental Services.

# Water Saving Tips to Help You Save Money on Your Next Water/Sewer Bill

- **1.** Check faucets and pipes for leaks. A small drip from a worn faucet washer can waste 20 gallons of water per day. Larger leaks can waste hundreds of gallons.
- **2.** Check your toilets for leaks. Put a little food coloring in your toilet tank. If, without flushing, the color begins to appear in the bowl within 30 minutes, you have a leak that should be repaired immediately. Most replacement parts are inexpensive and easy to install.
- **3.** Use your water meter to check for hidden water leaks. Read the house water meter before and after a two-hour period when no water is being used. If the meter does not read exactly the same, there is a leak.
- **4.** Install water-saving shower heads and low-flow faucet aerators. Inexpensive water-saving low-flow shower heads or restrictors are easy for the homeowner to install. Long, hot showers can use five to ten gallons every unneeded minute. "Low-flow" means it uses less than 2.5 gallons per minute (gpm). Also, all household faucets should be fit with low-flow aerators. 2.5 gpm may be needed in a kitchen sink but bathroom faucets and other water outlets should be 1.5 gpm or lower. Check gpm rating on packaging to be sure the advertised "low-flow" is at or below these levels. This single best home water conservation method is also the least expensive!
- **5.** Insulate your water pipes. It's easy and inexpensive to insulate your

- water pipes with pre-slit foam pipe insulation. You'll get hot water faster plus avoid wasting water while it heats up.
- **6.** *Take shorter showers.* One way to cut down on water use is to turn off the shower after soaping up, then turn it back on to rinse. A fourminute shower uses approximately 20 to 40 gallons of water. Limit your showers to the time it takes to soap up, wash down and rinse off.
- **7.** Turn off the water after you wet your toothbrush. There is no need to keep the water running while brushing your teeth. Just wet your brush and fill a glass for mouth rinsing.
- **8.** Rinse your razor in the sink. Fill the sink with a few inches of warm water. This will rinse your razor just as well as running water, with far less waste of water.
- **9.** Use your dishwasher and clothes washer for only full loads. Automatic dishwashers and clothes washers should be fully loaded for optimum water conservation. Most makers of dishwashing soap recommend not pre-rinsing dishes which is a big water savings. With clothes washers, avoid the permanent press cycle, which uses an added 20 liters (5 gallons) for the extra rinse. For partial loads, adjust water levels to match the size of the load. Replace old clothes washers. New Energy Star rated washers use 35 50% less water and 50% less energy per load. If you're in the market for a new clothes washer, consider buying a water-saving frontload washer.
- **10.** Keep a bottle of drinking water in the fridge. Running tap water to cool it off for drinking water is wasteful. Store drinking water in the fridge in a safe drinking bottle.

# How to Improve Recycling
