- **Article 9:** PASSED by paper ballot. 134 ballots cast, 119 Yes, 14 No, 1 Blank. (2/3 majority required) To enter into a 10-year lease/purchase in the amount of \$265,000 for two one-ton dump trucks and one fully equipped (plow, wing, and sand/salt spreader) truck (GVW 25,100) for the Department of Public Works in the amount of \$265,000.
- **Article 10:** PASSED unanimously by voice vote: Budget of \$5,477,561
- **Article 11:** PASSED by paper ballot. 128 ballots cast, 110 Yes, 18 No, 0 Blank. To enter into a 4 year lease/purchase agreement in the amount of \$30,000 for one cruiser for the Police Department.
- **Article 12:** PASSED unanimously by voice vote: \$291,783 to be placed in the Capital Improvement Plan Capital Reserve.
- **Article 13:** PASSED by voice vote: \$10,000 for permitting and engineering for the repair of the Route 4A Mascoma Lake Boat Launch parking lot.
- **Article 14:** PASSED unanimously by voice vote: Authorize the prepayment of taxes and authorize the tax collector to accept these payments.
- **Article 15:** PASSED by paper ballot. 133 ballots cast, 117 Yes, 16 No. To modify an Exemption for the disabled for qualified taxpayers, increasing the income limit for single taxpayers to \$26,000 and married taxpayers to \$36,000.
- **Article 16:** PASSED by paper ballot. 121 ballots cast, 104 Yes, 14 No, 3 Blank. To modify the elderly exemptions for qualified taxpayers, increasing the income limit for single taxpayers to \$26,000 and married taxpayers to \$36,000.
- **Article 17:** PASSED unanimously by voice vote: To amend the Tax Incremental Finance (TIF) District Plan, Section V. District Plan, Project List by adding the new municipal parking lot construction (up to \$150,000) to serve the town, police, and new library buildings, and the Lovejoy Brook Road culvert replacement.
- **Article 18:** PASSED by voice vote: To accept a piece of real estate approximately 1.5 acres located off Lovejoy Brook Road. Said property is owned by Robert LaCroix, is identified as Map 15 Lot 5, and is adjacent to the property on which the municipal Prior Well is located and is within the wellhead protection zone.

Article 19: PASSED by voice vote: In support allowing the use of an approximately 2.0 acre portion of the idle field adjacent to the Shaker Recreation Park on Route 4A (Tax Map 11, Lot 44) for a volunteer funded and managed off-leash fenced municipal dog park.

NOTE: The proposed amendment to Article 19 FAILED.

Article 20: PASSED unanimously by voice vote: To transfer \$2,000 from the 12/31/2013 unreserved fund balance to the Cemetery Maintenance Expendable Trust Fund. This money represents 2013 revenue from the sale of cemetery lots.

Article 21: PASSED unanimously by voice vote: To hear the reports of agents, auditors, committees, or any other officers heretofore chosen and pass any vote relating thereto.
