Article 4: Operating Budget

Shall the Mascoma Valley Regional School District raise and appropriate as an operating budget, not including appropriations by special warrant articles and other appropriations voted separately, the amounts set forth on the budget posted with the warrant or as amended by vote of the first deliberative session, for the purposes set forth therein, totaling Twenty-Seven Million, Five Hundred Seventy-Two Thousand, Five Hundred Eighty-Four (\$27,572,584) Dollars? Should this article be defeated, the default budget shall be Twenty-Seven Million, Two Hundred Eighty-Two Thousand, Five Hundred Twenty-Three (\$27,282,523) Dollars, which is the same as last year, with certain adjustments required by previous action of the Mascoma Valley Regional School District or by law; or the governing body may hold one special meeting, in accordance with RSA 40:13, X and XVI to take up the issue of a revised operating budget only.
